## Chairman's Statement 主席報告

On behalf of the board (the "Board") of directors (the "Directors") of Geotech Holdings Ltd. (the "Company", together with its subsidiaries, the "Group", "we", "our" or "us"), I present the audited annual results of the Group for the year ended 31 December 2024.

Looking back on the year, the fierce competition within slope works industry still posed challenges to the construction and engineering business of the Group while the development of property-related services of the Group kept growing steadily. In order to diversify the Group's business and broaden the Group's source of revenue to mitigate the challenging operating environment, the Group has developed sales of luxury products business to capture the opportunities of the market growth of luxury products.

For the year ended 31 December 2024, the Group's revenue decreased by 40.2% from approximately HK\$134.6 million in 2023 to approximately HK\$80.5 million in 2024. During the year, most of the Group's revenue were still contributed from the construction and engineering services, while the decrease in revenue was mainly due to the completion of certain major slope works projects in 2023 and 2024 while newly awarded major projects were still at the beginning stage during the year. For the Group's property-related services, the revenue remained steadily growing and increased by 6.7% from approximately HK\$8.4 million in 2023 to approximately HK\$9.0 million in 2024. In addition, the Group developed a new business segment for the sales of luxury products in the fourth quarter of 2023, which contributed revenue and gross profit of approximately HK\$10.4 million and HK\$2.0 million during the year respectively. Further details of business performances of the Group for the year ended 31 December 2024 are set out in the section headed "MANAGEMENT DISCUSSION AND ANALYSIS" in this annual report.

Going forward, the prospect of Group's construction and engineering services and property-related services is expected to be challenging in the coming years. The Group will continue to review its existing operations and businesses to formulate long-term business strategies (especially for site formation works and ground investigation field works) and focus on improving the Group's profitability. The Group will adopt a diligent and thoughtful business approach while formulating tailored strategies to effectively drive the sales growth of luxury products.

In addition, the Group will continue to optimise and diversify our business operations, and continue to explore or seek other appropriate business opportunities to strengthen and consolidate the Group's revenue base.

I strongly believe that the Group will be able to share the benefits of its continuous growth with our shareholders and deliver a greater shareholders' value in the very near future. Last but not least, I would like to express my deep gratitude to the Board and the employees of the Group for their hard work, professionalism and valuable contributions. I would also like to express my sincere gratitude to our customers, suppliers and other business partners for their trust and continued support.

本人謹代表致浩達控股有限公司(「本公司」)董事(「董事」) 會(「董事會」),提呈本公司及其附屬公司(「本集團」或「我們」)截至二零二四年十二月三十一日止年度的經審核全年業績。

回顧本年度,斜坡工程業界內的激烈競爭仍為本集團的建築及工程業務帶來挑戰,而本集團物業相關服務則保持穩定發展。為多元化本集團的業務及開拓本集團的收入來源以應對當前經營環境的挑戰,本集團已開拓奢侈品銷售業務以捕捉奢侈品市場增長的機遇。

截至二零二四年十二月三十一日止年度,本集團的收益由二零二三年的約1億3,460萬港元減少40.2%至二零二四年的約8,050萬港元。於本年度,建築及工程服務依然貢獻本集團大部分收益,收益減少主要因為於二零二三年及二零二四年若干主要斜坡工程項目已完成,而新獲授的主要工程項目於年內仍在初期階段。本集團物業相關服務方面,收益維持穩定增長,由二零二三年的約840萬港元增加6.7%至二零二四年的約900萬港元。此外,本集團於二零二三年第四季開拓新經營分部以銷售奢侈品,該業務於年內分別貢獻約1,040萬港元收益及約200萬港元毛利。有關本集團截至二零二四年十二月三十一日止年度的業務表現的進一步詳情載於本年報「管理層討論及分析」一節。

展望未來,預期未來數年本集團的建築及工程服務及物業相關服務前景將持續面臨挑戰。本集團會繼續審視現有之營運及業務以制定長遠業務策略(尤其為地盤平整工程及場地勘測工程)並專注改善本集團的盈利表現。本集團將採取全面周到的經營方針及制定適當策略,以有效推進奢侈品銷售的增長。

另外,本集團將持續優化及多元化我們的業務運作,及繼續探索或尋求其他合適的業務機會,以強化並鞏固本集團的收益基礎。

本人深信,本集團於不久將來能與各股東分享本集團持續發展效益,並可為各股東帶來更高的股東價值。最後,本人謹向董事會全人及本集團所有員工之忠誠努力、專業精神與寶貴貢獻致以衷心謝意,亦向客戶、供貨商及其他合作夥伴對本集團的信任和持續支持致以衷心的感謝。

# Management Discussion and Analysis 管理層討論及分析

## **BUSINESS REVIEW**

The Group was principally engaged in the provision of (i) construction and engineering services; (ii) property-related services; and (iii) sales of luxury products for the year ended 31 December 2024.

## **Construction and Engineering Services**

Geotech Engineering Limited ("Geotech Engineering"), an indirect wholly-owned subsidiary of the Company, is principally engaged in construction and engineering services and a leading slope works contractor in Hong Kong with over 20 years of experience in the civil engineering industry. It is an approved specialist contractor included in the List of Approved Specialist Contractors for Public Works maintained by the Development Bureau (the "DB") under the categories of "Landslip preventive/remedial works to slopes/retaining walls" (the "LPM") (confirmed status) and "Ground investigation field work" (Group I status) and also an approved contractor included in the List of Approved Contractors for Public Works under the category of "Site formation" (Group B probationary status). In addition, Geotech Engineering is also registered as a specialist contractor in the categories of site formation works and ground investigation field works with the Building Authority.

Total revenue of construction and engineering services for the year ended 31 December 2024 amounted to approximately HK\$61.1 million, representing a decrease of approximately 50.2% as compared with total revenue of approximately HK\$122.8 million last year. Such decrease in revenue was mainly due to the completion of certain major slope works projects while newly awarded major projects were still at the beginning stage during the year. Revenue in this segment continued to be deriving principally from slope works, ground investigation field works and road and drainage works, with public sector projects including those from the Landslip Prevention and Mitigation Programme (the "Programme") commissioned by the Civil Engineering and Development Department, other government departments and statutory bodies, which amounted to approximately 62.0% of total revenue in this segment (2023: approximately 87.5%).

## 業務回顧

截至二零二四年十二月三十一日止年度,本集團主要從事提供(i)建築及工程服務:(ii)物業相關服務;及(iii)奢侈品銷售。

#### 建築及工程服務

本公司的一間間接全資附屬公司土力資源有限公司(「土力資源」),主要從事建築及工程服務並憑藉於土木工程行業逾二十年的經驗成為香港首屈一指的斜坡工程承建商。其為名列於發展局所存置認可公共工程專門承建商名冊下的認可專門承建商,類別為「斜坡/擋土牆的防治山泥傾瀉/修補工程」(「LPM」)(核准資格)、「場地勘測工程」(1組資格):及亦為「地盤平整」(乙組試用承建商資格)類別項下的認可公共工程承建商名冊內的認可承建商。此外,土力資源亦註冊為屋宇署的地盤平整工程及場地勘測工程類別項下的專門承建商。

截至二零二四年十二月三十一日止年度建築及工程服務收益總額約6,110萬港元,較上年收益總額約1億2,280萬港元減少約50.2%。有關收益減少乃主要因為於年內若干主要斜坡工程項目已完成,而新獲授的主要工程項目於年內仍在初期階段。該分部收益繼續主要來自公營部門項目的斜坡工程、場地勘測工程及道路及渠務工程、包括來自土木工程拓展署委託的長遠防治山泥傾瀉計劃(「計劃」)、其他政府部門及法定實體的工程,金額佔該分部收益約62.0%(二零二三年:約87.5%)。

During the year, Geotech Engineering has continued its strategy for construction and engineering services in Hong Kong through a variety of operational initiatives:

- in response to keen market competition, although securing new contracts had been difficult during the year, the Group has continued to submit tenders but is cautious about the pricing so as to maintain a reasonable gross profit margin while at the same time remaining competitive. The strategy to maintain a reasonable gross profit might have contributed to some tenders not having been awarded to the Group;
- in order to undertake more construction projects given Geotech Engineering's capacity, it has continued to focus on project management role and our collaboration with subcontractors by subcontracting a substantial part of works required; and
- other than slope works, the Group has continued to seek opportunities to diversify
  into other types of civil engineering works by tendering projects jointly with
  partners for contracts which involve various work categories (especially for site
  formation works and ground investigation field works). The Directors consider
  that this strategy is beneficial to the Group's diversification in construction and
  engineering services in Hong Kong.

As at 31 December 2024, the Group had 39 construction contracts on hand, including contracts in progress and contracts yet to commence (31 December 2023: 48 contracts) with a total outstanding contract sum of approximately HK\$288.9 million (31 December 2023: approximately HK\$179.1 million) and in which approximately HK\$114.4 million out of these contracts are expected to be completed in 2025.

## **Property-related Services**

The market environment for property-related services in Hong Kong was still challenging for the year given the uncertainties in the economic and business environment of Hong Kong. During the year, the Group recorded revenue of approximately HK\$8.7 million (2023: approximately HK\$8.4 million) and HK\$0.3 million (2023: HK\$nil) for the provision of property management consultancy services and property leasing agency services respectively. Of which, approximately HK\$4.7 million of property management consultancy services (2023: approximately HK\$4.6 million) and HK\$0.3 million of property leasing agency services (2023: HK\$ nil) respectively were generated from continuing connected transactions. Details of the continuing connected transactions are set out in note 28 to the consolidated financial statements and section headed "CONTINUING CONNECTED TRANSACTIONS" in this annual report. The Group has renewed the property management consultancy services agreements with all existing independent client during the year ended 31 December 2024.

## Sales of luxury products

The Group has expanded into sales of luxury products business segment in the fourth quarter of 2023. While the Group targets to expand its market presence by actively widening its customer base and collaborating with various suppliers to diversify its product offerings, it will adhere to its prudent business approach and devise appropriate business strategies based on market demand and development. The Group will continuously optimise its operations to improve profitability.

During the year, the Group recorded revenue of approximately HK\$10.4 million (2023: approximately HK\$3.4 million) for sales of luxury goods. Such increase in revenue was mainly due to the Group's stable growth in sales of luxury watches sector during the year.

於本年度,土力資源已透過不同的營運措施繼續其於香港 的建築及工程服務策略:

- 為應對激烈的市場競爭,儘管年內難以獲得新合約, 本集團繼續投標,但對定價持謹慎態度,力求維持 合理的毛利率,同時保持競爭力。維持合理毛利的 策略可能導致本集團部分標書未能中標;
- 土力資源為了能承接更多建築工程,其透過將大部分工程外包,以繼續專注於項目管理職責並與分包商合作;及
- 除斜坡工程外,本集團已透過與合作夥伴共同投標 涉及各種工程類別(尤其是地盤平整工程及場地勘測 工程)合約的項目,以多元化其他土木工程類型。董 事認為,該策略有利於本集團在香港多元化建築及 工程服務。

於二零二四年十二月三十一日,本集團手頭擁有39項建築 合約,包括進行中合約及尚未開始合約(二零二三年十二月 三十一日:48項合約),未完成合約總金額為約2億8,890萬 港元(二零二三年十二月三十一日:約1億7,910萬港元), 而該等合約中約1億1,440萬港元預期將於二零二五年竣工。

## 物業相關服務

鑑於香港經濟及營商環境不明朗,本年度香港物業相關服務的市場環境仍充滿挑戰。於本年度,本集團在提供物業管理顧問服務及物業租賃代理服務錄得收益分別約870萬港元(二零二三年:約840萬港元)及30萬港元(二零二三年:零港元)。其中,約470萬港元(二零二三年:約460萬港元)的物業管理顧問服務及約30萬港元(二零二三年:零港元)的物業租賃代理服務來自持續關連交易。相關持續關連交易詳情載於綜合財務報表附註28及本年報之「持續關連交易」一節。本集團已於截至二零二四年十二月三十一日止年度內與所有現有獨立客戶續期物業管理顧問服務協議。

## 奢侈品銷售

本集團已於二零二三年第四季擴展至奢侈品銷售業務分部。 本集團旨在透過積極擴大其客戶群,並與不同供應商合作 以多元化發展其產品組合,從而擴大其市場影響力,同時 將堅持其審慎的業務方針,根據市場需求及發展制定適當 的業務策略。本集團將持續優化營運,以提高盈利能力。

年內,本集團錄得奢侈品銷售收益約1,040萬港元(二零二三年:約340萬港元)。收益增加主要由於年內本集團的名貴 鐘錶的銷售穩定增長所致。

## **OUTLOOK**

Apart from focusing on construction and engineering services and property-related services in Hong Kong, the Group has expanded into the sales of luxury products in the fourth quarter of 2023. the Group will continue to explore other business expansion in order to enhance the future development and strengthen the revenue bases of the Group. The Board believes that the Group's strategy to diversify its business could provide a better return to the shareholders of the Company (the "Shareholders").

In line with the Board's strategy as stated above, the Group is taking a cautious approach for future development:

- the dilemma between winning tenders at extremely thin gross profit margin
  and submitting tenders at a reasonable gross profit margin exists in every tender
  opportunity. The Group strives to strike a delicate balance between winning
  contracts for the business and making profits for its shareholders;
- having considered the industry conditions of the construction and engineering services in Hong Kong, the Group will closely monitor the market and respond to changes in market conditions. Going forward, in order to broaden the types of works in the construction and engineering sector other than slope works, Geotech Engineering strives to partner with potential partner(s) for tendering projects in various types of civil engineering works (especially for site formation works and ground investigation field works);
- taking into consideration the market circumstances in Cambodia, the Group will take a cautious approach in the development of our construction and decoration business in Cambodia:
- although our property-related services are expected to remain challenging in the
  coming years given the uncertainties in the economic and business environment of
  Hong Kong, by leveraging our management experiences and knowledge gained in
  the industry, the Group will strive to seek various opportunities in property-related
  services:
- due to the uncertainties in the economic and business environment of Hong Kong, the Group will continue to adopt a prudent approach regarding its inventory management of luxury products in order to lower costs. The Group will also actively explore potential partnership with new suppliers and expand customer base to diversity business risks; and
- in addition to the above, the Group may also seek to diversify and explore other investment opportunities in the future.

The Group will continue to monitor the situation and assess the market risks and uncertainties during the economic recovery cycle and strive to take strict measures to mitigate any potential adverse impact on the Group.

## 前景

本集團已於二零二三年第四季擴展至奢侈品銷售,未來亦將繼續尋求其他業務擴張,而非僅限於專注香港市場的建築及工程服務以及物業相關服務,以提升本集團未來發展及增強本集團的收益基礎。董事會認為,本集團的多元化業務策略能為本公司股東(「股東」)帶來更佳回報。

為符合上述董事會策略,本集團就未來發展採取以下審慎 措施:

- 每個投標機會都面臨一個難題:以極低的毛利率競標成功,還是以合理的毛利率投標。本集團致力於在贏取業務合約及為股東創造利潤之間尋求巧妙的平衡;
- 經考慮香港建築及工程服務的行業狀況,本集團將密切監察市場並根據市況的變動做出應對。展望未來,為擴展建築及工程行業中不同工程(除斜坡工程外),土力資源力求與潛在合作夥伴合作,以投標多類土木工程的項目(尤其是地盤平整工程及場地勘測工程);
- 經考慮柬埔寨市況,本集團將採取審慎措施,發展 位於柬埔寨的建築及裝飾業務;
- 考慮到香港經濟及經營環境的不確定性,預計未來 幾年物業相關服務的市場環境仍充滿挑戰,憑藉我 們於該行業所獲得的管理經驗及知識,本集團將致 力於尋求其他物業相關業務機會;
- 由於香港經濟及營商環境的不確定性,本集團將繼續對奢侈品的存貨管理採取審慎態度,以降低成本。本集團亦將積極探索與新供應商的潛在合作夥伴關係,並擴大客戶群,以分散業務風險;及
- 除上述者外,本集團日後亦可能尋求多元化及探索 其他投資機會。

本集團將於經濟復蘇周期繼續監察狀況並評估當中的市場 風險及不確定性,並努力採取嚴格措施以減輕任何對本集 團的潛在不利影響。

## **FINANCIAL REVIEW**

#### Revenue

The Group's total revenue decreased by approximately HK\$54.1 million or approximately 40.2% from approximately HK\$134.6 million for the year ended 31 December 2023 to approximately HK\$80.5 million for the year ended 31 December 2024. The Group's total revenue for the year was contributed by construction and engineering services, property-related services and sales of luxury products.

## (a) Construction and Engineering Services

The Group's revenue generated from construction and engineering services decreased by approximately HK\$61.7 million or approximately 50.2% from approximately HK\$122.8 million for the year ended 31 December 2023 to approximately HK\$61.1 million for the year ended 31 December 2024. Such decrease in revenue was mainly due to the completion of certain major slope works projects while newly awarded major projects were still at the beginning stage during the year.

## (b) Property-related Services

The Group's revenue from property-related services remained stable for the year ended 31 December 2024 as compared with the year ended 31 December 2023 which included continuing connected transactions amounting to approximately HK\$5.0 million (2023: approximately HK\$4.6 million) and the details of which are set out in note 28 to the consolidated financial statements and the section headed "CONTINUING CONNECTED TRANSACTIONS" in this annual report.

#### (c) Sales of luxury products

The Group's revenue from sales of luxury products increased by approximately HK\$7.0 million or approximately 207.5% from approximately HK\$3.4 million for the year ended 31 December 2023 to approximately HK\$10.4 million for the year ended 31 December 2024. Such increase in revenue was mainly due to the stable growth in the sales of luxury watches sector as a result of the Group's expansion into sales of luxury products market.

## 財務回顧

## 收益

本集團的收益總額由截至二零二三年十二月三十一日止年度約1億3,460萬港元減少約5,410萬港元或約40.2%至截至二零二四年十二月三十一日止年度約8,050萬港元。本集團於本年度的收益總額由建築及工程服務、物業相關服務及奢侈品銷售貢獻。

## (a) 建築及工程服務

本集團來自建築及工程服務的收益由截至二零二三年十二月三十一日止年度約1億2,280萬港元減少約6,170萬港元或約50.2%至截至二零二四年十二月三十一日止年度約6,110萬港元。收益減少主要因為若干主要斜坡工程項目已完成,而新獲授的主要工程項目於年內仍在初期階段。

### (b) 物業相關服務

本集團的物業相關服務收益於截至二零二四年十二 月三十一日止年度與截至二零二三年十二月三十一 日止年度相比維持穩定。當中一項收益為持續關連 交易,收益額為約500萬港元(二零二三年:約460萬 港元),詳情載於綜合財務報表附註28及本年報之「持 續關連交易」一節。

## (c) 奢侈品銷售

本集團奢侈品銷售的收益由截至二零二三年十二月三十一日止年度約340萬港元增加約700萬港元或約207.5%至截至二零二四年十二月三十一日止年度約1,040萬港元。收益增加乃主要由於本集團擴展至奢侈品銷售市場後,名貴手錶的銷售穩定增長。

## **Gross Profit and Gross Profit Margin**

The Group's total gross profit for the year ended 31 December 2024 amounted to approximately HK\$5.4 million, representing an increase of 50.6% as compared with approximately HK\$3.6 million for the year ended 31 December 2023. The Group's gross profit margin for the year ended 31 December 2024 was approximately 6.7%, as compared with approximately 2.7% for the year ended 31 December 2023.

## (a) Construction and Engineering Services

The gross profit from construction and engineering services for the year ended 31 December 2024 amounted to approximately HK\$0.6 million, representing an increase of 150% as compared with approximately HK\$0.2 million for the year ended 31 December 2023. The gross profit margin from construction and engineering services for the year ended 31 December 2024 was approximately 1.0%, as compared with approximately 0.2% for the year ended 31 December 2023. The increase in gross profit and gross profit margin was mainly due to the cost optimisation as a result of manpower restructuring during the year.

## (b) Property-related Services

The gross profit from property-related services for the year ended 31 December 2024 amounted to approximately HK\$2.8 million, representing an increase of approximately HK\$0.4 million as compared with approximately HK\$2.4 million for the year ended 31 December 2023. The gross profit margin for the year ended 31 December 2024 was approximately 31.5%, as compared with approximately 28.2% for the year ended 31 December 2023. The increase in gross profit margin was mainly due to the property leasing agency services income of approximately HK\$0.3 million recognised for the year ended 31 December 2024 (2023: nil).

## (c) Sales of luxury products

The gross profit from sales of luxury products for the year ended 31 December 2024 amounted to approximately HK\$2.0 million, representing an increase of approximately 100% as compared with approximately HK\$1.0 million for the year ended 31 December 2023. The gross profit margin for the year ended 31 December 2024 was approximately 18.8%, as compared with approximately 28.6% for the year ended 31 December 2023. The decrease in gross profit margin was mainly due to the increase in the direct selling expenses incurred during the year.

#### **Other Income**

Other income mainly included bank interest income, material charges income and sundry income. For the year ended 31 December 2024, other income amounted to approximately HK\$3.6 million (2023: approximately HK\$4.9 million). The decrease in other income was mainly due to the decrease in handling charges paid by subcontractors requesting our assistance in the procurement of construction materials for our construction contracts.

## 毛利及毛利率

本集團截至二零二四年十二月三十一日止年度的毛利總額 為約540萬港元,較截至二零二三年十二月三十一日止年 度之約360萬港元增加50.6%。本集團截至二零二四年十二 月三十一日止年度之毛利率為約6.7%,而截至二零二三年 十二月三十一日止年度為約2.7%。

## (a) 建築及工程服務

截至二零二四年十二月三十一日止年度的建築及工程服務的毛利為約60萬港元,較截至二零二三年十二月三十一日止年度約20萬港元增加150%。截至二零二四年十二月三十一日止年度的建築及工程服務的毛利率為約1.0%,而截至二零二三年十二月三十一日止年度則為約0.2%。毛利及毛利率增加主要由於年內人力重組導致成本優化所致。

## (b) 物業相關服務

截至二零二四年十二月三十一日止年度來自物業相關服務的毛利為約280萬港元·較截至二零二三年十二月三十一日止年度之約240萬港元增加約40萬港元。截至二零二四年十二月三十一日止年度的毛利率為約31.5%,而截至二零二三年十二月三十一日止年度為約28.2%。毛利率增加主要由於截至二零二四年十二月三十一日止年度確認物業租賃代理服務收入約30萬港元(二零二三年:無)所致。

## (c) 奢侈品銷售

截至二零二四年十二月三十一日止年度的奢侈品銷售的毛利為約200萬港元·較截至二零二三年十二月三十一日止年度約100萬港元增加約100%。截至二零二四年十二月三十一日止年度的毛利率為約18.8%,而截至二零二三年十二月三十一日止年度則為約28.6%。毛利率減少主要由於年內產生的直接銷售開支增加。

## 其他收入

其他收入主要包括銀行利息收入、材料費收入及雜項收入。 截至二零二四年十二月三十一日止年度,其他收入為約360 萬港元(二零二三年:約490萬港元)。其他收入減少主要由 於分包商就請求我們協助採購建築合約的建築材料所支付 的手續費減少所致。

## **Administrative Expenses**

Administrative expenses primarily comprise staff costs, depreciation and legal and professional fees. The administrative expenses of the Group for the year ended 31 December 2024 amounted to approximately HK\$24.5 million, representing a decrease of approximately 2.1% as compared with approximately HK\$25.0 million for the year ended 31 December 2023. The administrative expenses remained stable for the years ended 31 December 2024 and 2023.

#### **Finance Costs**

Finance costs represent finance charge on lease liabilities and net interest expense on long service payment obligations. Finance costs for the year ended 31 December 2024 was approximately HK\$67,000, representing an increase of approximately 91.4% compared with approximately HK\$35,000 for the year ended 31 December 2023. The increase was mainly attributable to the commencement of new lease on premise during the year.

## **Income Tax Expense**

Income tax expense of approximately HK\$285,000 was recognised for the year ended 31 December 2024 as compared with an income tax expense of approximately HK\$17,000 for the year ended 31 December 2023, resulting from an increase in deferred tax expense during the year.

## **Net Loss**

Net loss for the year ended 31 December 2024 amounted to approximately HK\$15.8 million, as compared to the net loss of approximately HK\$16.4 million for the year ended 31 December 2023. Despite the decrease in other income, the reduction in the Group's net loss was mainly due to the increase in gross profit as discussed above. The Group's net loss margin for the year ended 31 December 2024 was approximately 19.6%, as compared to approximately 12.2% for the year ended 31 December 2023.

#### **Final Dividend**

The Board did not recommend the payment of any final dividend for the year ended 31 December 2024 (2023: nil).

## 行政開支

行政開支主要包括員工成本、折舊以及法律及專業費用。本集團截至二零二四年十二月三十一日止年度的行政開支約為2,450萬港元,較截至二零二三年十二月三十一日止年度約2,500萬港元減少約2.1%。截至二零二四年及二零二三年十二月三十一日止年度,行政開支維持穩定。

## 財務成本

財務成本指租賃負債的融資費用以及長期服務金責任的利息開支淨額。截至二零二四年十二月三十一日止年度的財務成本約為67,000港元,較截至二零二三年十二月三十一日止年度的約35,000港元增加約91.4%。該增加主要歸因於年內新物業租約開始所致。

## 所得税開支

截至二零二四年十二月三十一日止年度確認所得税開支約 285,000港元,而所得税開支截至二零二三年十二月三十一 日止年度約17,000港元,由於年內遞延税項開支增加所致。

### 虧損淨額

截至二零二四年十二月三十一日止年度的虧損淨額為約1,580 萬港元,而截至二零二三年十二月三十一日止年度的虧損 淨額約1,640萬港元。儘管其他收入減少,本集團的虧損淨 額減少主要由於如上所述毛利增加所致。本集團於截至二 零二四年十二月三十一日止年度的淨虧損率為約19.6%,而 截至二零二三年十二月三十一日止年度為約12.2%。

### 末期股息

董事會不建議派付截至二零二四年十二月三十一日止年度 的任何末期股息(二零二三年:無)。

## **Liquidity, Financial Resources and Capital Structure**

As at 31 December 2024, the Company's issued share capital was HK\$16.8 million and the number of issued ordinary shares of the Company (the "**Shares**") was 1,680 million with par value of HK\$0.01 each. There has been no change in the capital structure of the Group since the listing of the Company's Shares on the Main Board of the Stock Exchange on 12 October 2017 (the "**Listing**").

As at 31 December 2024, the Group had total cash and bank balances of approximately HK\$121.4 million (31 December 2023: approximately HK\$137.2 million). The Group had no bank borrowing as at 31 December 2024 (31 December 2023: nil). Other borrowings of the Group as at 31 December 2024 were lease liabilities of approximately HK\$0.7 million (31 December 2023: approximately HK\$1.4 million). Details of lease liabilities are set out in note 21 to the consolidated financial statements in this annual report. All borrowings were denominated in Hong Kong dollars. The interest rates on lease liabilities were charged at fixed rates with effective rate at 4.41% for the year ended 31 December 2024 (2023: 4.23% to 4.78%). The Group did not carry out any interest rate hedging policy.

## **Treasury Policy**

The Group has adopted a prudent financial management approach towards its treasury policy. The Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities, and other commitments can meet its funding requirements all the time.

#### **Gearing ratio**

Gearing ratio is calculated by dividing total borrowings by total equity as at the yearend date and multiplied by 100%. As at 31 December 2024, the total borrowings of the Group were the lease liabilities of approximately HK\$0.7 million (31 December 2023: approximately HK\$1.4 million). The gearing ratio of the Group as at 31 December 2024 was approximately 0.4% (31 December 2023: approximately 0.8%). The decrease in gearing ratio was mainly due to lower total indebtedness level resulting from repayment of lease liabilities of the Group during the year.

#### **Pledge of Assets**

As at 31 December 2024 and 2023, no asset of the Group was pledged.

本集團針對其庫務政策採取審慎的財務管理辦法。董事會密切監察本集團的流動資金狀況,確保本集團的資產、負債及其他承擔的流動資金架構能夠滿足其資金需求。

## 資本負債比率

資本負債比率按年終日期的借款總額除以權益總額再乘以 100%計算。本集團於二零二四年十二月三十一日的借款總 額為租賃負債約70萬港元(二零二三年十二月三十一日:約 140萬港元)。本集團於二零二四年十二月三十一日的資本 負債比率為約0.4%(二零二三年十二月三十一日:約0.8%)。 資本負債比率降低主要由於年內本集團償還租賃負債使總 債務水平較低。

#### 資產抵押

於二零二四年及二零二三年十二月三十一日,本集團並無 資產被質押。

## **Foreign Exchange Exposure**

The Group mainly operates in Hong Kong. Most of the operating transactions and revenue are settled in Hong Kong dollars and the assets and liabilities are primarily denominated in HK\$. The Group's exposures to foreign exchange mainly arise from its cash and bank deposits denominated in United States Dollars ("US\$") amounting to approximately HK\$37.8 million as at 31 December 2024 (31 December 2023: approximately HK\$37.1 million). Most of the operating transactions from the Group's operation in Cambodia are settled in US\$.

However, HK\$ is pegged to US\$ under the Linked Exchange Rate System, the Group is not exposed to any significant foreign exchange risk against US\$ and therefore has not entered into any derivatives agreement nor committed to any financial instrument to hedge its foreign exchange exposure during the year ended 31 December 2024 (2023: nil).

# Significant Investments Held, Material Acquisitions and Disposals of Subsidiaries, Joint Ventures and Associated Companies

During the year ended 31 December 2024, the Group did not have any significant investments held, material acquisitions and disposals of subsidiaries, joint ventures and associated companies.

## **Future Plans for Material Investments or Capital Assets**

Save as disclosed under the section headed "Use of Net Proceeds from the listing of the shares of the Company on 12 October 2017" in this annual report, the Group did not have other future plans for material investments or capital assets as at 31 December 2024.

#### **Employees and Remuneration Policies**

As at 31 December 2024, employees who were on the Group's payroll included 60 full-time employees (31 December 2023: 65 full-time employees). For the year ended 31 December 2024, total staff costs (including Directors' remuneration) amounted to approximately HK\$29.0 million (2023: approximately HK\$30.6 million). Total staff costs comprised salaries, Directors' fee, wages and allowances, discretionary bonuses and retirement scheme contributions. In order to attract and retain high quality staff and to enable smooth operation within the Group, the remuneration policy of the Group's employees are being reviewed periodically to ensure that the salary and benefit levels of employees of the Group are competitive (with reference to market conditions and individual qualifications, position, performance and experience). The Group continues to provide adequate job training to the employees to equip them with practical knowledge and skills. Apart from the defined contribution retirement plan in Hong Kong and Cambodia and job training programs, salary increments and discretionary bonuses are being awarded to employees according to the assessment of individual performance and market situation. For remuneration policies of the Directors and senior management and share option schemes, please refer to sections headed "REMUNERATION COMMITTEE" and "SHARE OPTION SCHEME" in this annual report respectively.

Based on the information available, the Board considered that the Group has sufficient insurance coverage on any liability arising from those claims, litigations and potential claims.

As such, the Board is of the view that such claims, litigations and potential claims would not cause any material adverse impact on the operation and financial position of the Group and no provision is required to be made in the consolidated financial statements.

# Use of Net Proceeds from the listing of shares of the Company on 12 October 2017

Net proceeds from the Listing ("**Net Proceeds**") amounted to approximately HK\$72.8 million. As at 31 December 2024, a total amount of approximately HK\$68.0 million out of the Net Proceeds had been used by the Group and approximately HK\$4.8 million remained unused.

As at 31 December 2024, the unused amount of Net Proceeds was placed in interest-bearing deposits with licensed banks in Hong Kong. The Group will gradually apply the remaining Net Proceeds for the acquisition of site facilities and equipment (being consistent with the purposes as set out in prospectus of the Company dated 28 September 2017 (the "**Prospectus**")) in accordance with actual business needs and expects to use up the remaining Net Proceeds within one year (i.e. on or before the end of year 2025). The code provisions applicable for the year ended 31 December 2024 and as set out in the Corporate Governance Code (the "CG Code") contained in Part 2 of Appendix C1 to the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") have been adopted as the Company's corporate governance practices. The Board will continue to review and enhance the corporate governance practices to ensure compliance with the CG Code and align with the latest developments.

## **Compliance with the Corporate Governance Code**

The Company has adopted and complied with the applicable code provisions (the "Code Provision(s)") as set out in the CG Code contained in Part 2 of Appendix C1 to the Listing Rules during the year ended 31 December 2024. The Directors will periodically review the Company's corporate governance policies and will propose any amendment, if necessary, to ensure compliance with the CG Code from time to time.

## **Role and function**

The Board is primarily responsible for directing and supervising the affairs of the Group, including but not limited to overall business development, all significant financial, operational and strategic decisions, internal controls and risk management assessment, review of corporate governance policies and practices and other functions reserved to the Board under the second amended and restated memorandum and articles of association of the Company (the "Articles"). The management is responsible for the day-to-day operations of the Group. To oversee particular aspects of the Company's affairs, the Board has established Board committees including the Audit Committee, the Nomination Committee and the Remuneration Committee (together, the "Board Committees"). The Board has delegated to the Board Committees responsibilities as set out in their respective terms of reference. Further details of these committees are set out in the sections headed "AUDIT COMMITTEE", "NOMINATION COMMITTEE" and "REMUNERATION COMMITTEE" below.

### Composition

As at the date of this annual report, the Board is chaired by Mr. Chen Zhi and comprised five members, consisting of two executive Directors and three independent non-executive Directors. The list of Directors is set out in the section headed "DIRECTORS' REPORT" in this annual report. Biographical details of Directors are set out in the section headed "BIOGRAPHICAL DETAILS OF DIRECTORS AND SENIOR MANAGEMENT" in this annual report.

#### **Board Diversity Policy and Workforce**

The Company has adopted a board diversity policy (the "Board Diversity Policy") which sets out the approach to achieve and maintain diversity on the Board in order to enhance the effectiveness of the Board. The Company will continue to review and enhance the Board Diversity Policy to ensure compliance with the CG Code and align with the latest developments.

The Company seeks to achieve board diversity through the consideration of a number of factors, including but not limited to gender, age, cultural and education background, experience, skills, knowledge and length of service.



The Board sets measurable objectives to implement the Board Diversity Policy and reviews such objectives from time to time to ensure their appropriateness and ascertain the progress made towards achieving those objectives. During the year ended 31 December 2024, the Nomination Committee has considered a number of factors including but not limited to the age, education background and experience when reviewing the structure, size and composition of the Board.

The Nomination Committee reviewed the Board Diversity Policy during the year, and consider the said policy as appropriate and effective. Such review will be performed annually, as appropriate, to ensure the effectiveness of the said policy form time to time.

The Board currently comprises one female Director and four male Directors. The Board has achieved the gender diversity target of at least 20% female Director(s), and the Board will continue to maintain gender diversity at Board level. The Board is of the view that the existing gender diversity in respect of the Board is sufficient, and that the board diversity policy and the nomination policy of the Company can ensure that there will be a pipeline of potential successors to the Board which continues the existing gender diversity in the Board.

During the year, the Board was not aware of any mitigating factors or circumstances which make achieving gender diversity across the workforce (including senior management) more challenging or less relevant.

The Board places emphasis on diversity (including gender diversity) across all levels of the Group. As at 31 December 2024, the Group had 60 full-time employees in total, comprising 44 males and 16 females (that is, a male to female ratio of approximately 2.8:1). The Group when hiring employees considers a number of factors, including but not limited to gender, age, cultural and education background, qualification, ethnicity, professional experience, skills, knowledge and length of service, and the Group will make sure achieving gender diversity across the workforce.

### **Nomination Policy**

The Company has adopted a nomination policy (the "Nomination Policy"), which establishes written guidelines to the Nomination Committee to identify individuals suitably qualified to become Board members and make recommendations to the Board on the selection of individuals nominated for directorships with reference to the formulated criteria. The Board is ultimately responsible for selection and appointment of new Directors. The Board, through the delegation of its authority to the Nomination Committee, has used its best efforts to ensure the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business. Collectively, they have competencies in areas which are relevant and valuable to the Group.

## **Dividend Policy**

The Company has adopted a dividend policy in deciding whether to propose a dividend and in determining the dividend amount, the Board shall take into account, among other things, the following factors:

- (i) the general financial condition of the Group;
- (ii) capital and debt level of the Group;
- future cash requirements and availability for business operations, business strategies and future development needs;
- (iv) any restrictions on payment of dividends that may be imposed by the Group's lenders;
- (v) the general market conditions; and
- (vi) any other factors that the Board deems appropriate.

The recommendation of the payment of dividend is subject to the determination of the Board, and any declaration of final dividend for the year will be subject to the approval of the Shareholders. The payment of dividend is also subject to any restrictions under the Companies Act of the Cayman Islands and any other applicable laws, rules and the Articles.

## 提名政策

本公司已採納提名政策(「提名政策」),該政策為提名委員會制定書面指引,以物色具備合適資格可成為董事會成員之人士,並就根據已制定標準提名有關人士出任董事向董事會提供建議。董事會最終負責甄選及委任新董事。董事會透過授權提名委員會已盡力確保董事會具備切合本公司業務要求的技能、經驗及多元觀點。總括而言,彼等在本集團相關及關鍵領域具有相應的能力。

建議派發股息須待董事會釐定,宣派本年度任何末期股息 將待股東批准後,方可作實。支付股息亦受開曼群島公司 法及任何其他適用法律、規則及細則之任何限制所規限。

## CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Under Code Provision C.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. In compliance with the CG Code, the position of the chairman and the chief executive officer of the Company are held by separate individuals.

As at the date of this annual report, Mr. Chen Zhi serves as the Chairman of the Board and is responsible for overall business development, financial and strategic planning of the Group. No chief executive officer has been appointed by the Company after resignation of Mr. Kung Ho Man on 30 November 2022. The overall construction projects management and the daily operation of the construction and engineering services of the Group are delegated to the other executive Directors and the management of the Company. The Board is of the view that the current management structure can effectively facilitate the Group's operation and business development.

#### INDEPENDENT NON-EXECUTIVE DIRECTORS

As at the date of this annual report, the Company has three independent non-executive Directors representing more than one-third of the Board in compliance with Rule 3.10(1) and 3.10A of the Listing Rules. Among the three independent non-executive Directors, Mr. Chan Tsang Mo and Ms. Yip Wai Ching have the appropriate professional qualifications in accounting or related financial management expertise in compliance with Rule 3.10(2) of the Listing Rules.

The independent non-executive Directors are considered by the Board to be independent of the management and free of any relationship that could materially interfere with the exercise of their independent judgments. The Board considered that each of the independent non-executive Directors brings his own relevant expertise to the Board and its deliberations. None of the independent non-executive Directors has any business or financial interests with the Group nor has any relationship with other Directors.

The Company has received annual confirmation from each independent non-executive Director of his independence pursuant to Rule 3.13 of the Listing Rules. The Company considers all independent non-executive Directors to be independent in accordance with the independence guidelines as set out in Rule 3.13 of the Listing Rules.

## APPOINTMENTS AND RE-ELECTIONS OF DIRECTORS

Each of the independent non-executive Directors has entered into a letter of appointment with the Company for an initial term of one year and thereafter shall continue year to year subject to termination provisions therein, provisions on retirement by rotation and reelection of Directors as set out in the Articles.

In accordance with Article 108(a) of the Articles, at each annual general meeting, one-third of the Directors for the time being, or, if their number is not three or a multiple of three, then the number nearest to but not less than one-third, shall retire from office by rotation provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years. A retiring Director shall be eligible for re-election.

## 主席及行政總裁

根據企業管治守則條文第C.2.1條,主席及行政總裁的角色 應有所區分,並不應由同一名人士擔任。為遵守企業管治 守則,本公司主席及行政總裁職務分別由不同人士擔任。

於本年報日期,陳志先生擔任董事會主席及負責本集團整體業務發展、財務及策略規劃。於二零二二年十一月三十日龔浩文先生離任後,本公司未再委任行政總裁,本集團的整體建築項目管理及建築及工程服務的日常營運獲委託予本公司其他執行董事及管理層。董事會認為,現有管理架構可有效促進本集團營運及業務發展。

## 獨立非執行董事

於本年報日期,本公司符合上市規則第3.10(1)及3.10A條規定有三名獨立非執行董事(佔董事會三分之一以上成員)。 於三名獨立非執行董事中,陳增武先生及葉慧貞女士符合 上市規則第3.10(2)條規定擁有適當的會計專業資格或相關 財務管理專業知識。

董事會認為,獨立非執行董事獨立於管理層及與管理層不存在任何關係致使嚴重影響彼等行使獨立判斷。董事會認為,各獨立非執行董事均為董事會及其決策貢獻本身的相關專業知識。獨立非執行董事並無涉及本集團的任何業務及財務利益,且與其他董事亦無任何關係。

本公司已根據上市規則第3.13條接獲每名獨立非執行董事就其獨立性而呈交之年度書面確認。按照上市規則第3.13條所載之獨立性指引,本公司認為全體獨立非執行董事均屬獨立。

## 董事之委任及重選

各獨立非執行董事已與本公司訂立初始任期為期一年的委 任函,且其後須按年受其中所述終止條文、細則所載董事 輪流退任及膺選連任條文所規限。

根據細則第108(a)條,在每屆股東週年大會上,當時三分之一董事(或倘人數並非三或三的倍數,則以最接近但不少於三分之一的人數為準)將輪值退任,惟每名董事(包括委任特定期限的董事)須至少每三年輪值退任一次。退任董事應合資格膺選連任。

In accordance with Article 112 of the Articles, any Director appointed by the Board to fill a casual vacancy shall hold office only until the first general meeting of the Company after his appointment and be subject to re-election at such meeting. Any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re- election. Any Director appointed under this Article 112 shall not be taken into account in determining the Directors or the number of Directors who are to retire by rotation at an annual general meeting.

- to review and monitor the training and continuous professional development of Directors and senior management of the Company;
- to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- to develop, review and monitor the code of conduct and compliance manual applicable to employees and Directors; and
- to review the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

The Board is responsible for performing the corporate governance functions set out in the Code Provision A.2.1 of the CG Code. As at the date of this annual report, the Board has reviewed and monitored (i) the Company's corporate governance policies and practices; (ii) training and continuous professional development of Directors and senior management; (iii) the Company's policies and practices on compliance with legal and regulatory requirements; (iv) the Company's code of conduct; and (v) the Company's compliance with the CG Code disclosure requirements.

## **DIRECTORS' INSURANCE**

The Company has arranged appropriate insurance coverage for all Directors in relation to the discharge of their responsibilities.

## RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges that it is its duty to monitor the risk management and internal control systems of the Group on an ongoing basis and review their effectiveness.

The Group has established guidelines and procedures for the approval and control of expenditures, to ensure the reliability of the financial reporting, effectiveness and efficiency of operation and the compliance with applicable laws and regulations. Whilst these guidelines and procedures are designed to identify and manage risks that could adversely impact the achievement of the Group's business objectives, they provide reasonable, but not absolute assurance against material misstatement, errors, losses, fraud or noncompliance.

The Group's internal control and risk management system are designed to safeguard the Group's assets and the interests of shareholders. The Group has established risk governance procedures to identify, evaluate and manage risks, including environmental, social and governance risks, associated with each operational department. Operational departments are responsible to identify and assess potential risks which may affect the Group's business operation and objectives. The potential risks are then evaluated by the senior management in terms of potential impact of risk and likelihood of occurrences. The identified risks after evaluated by the senior management are compiled in the risk register with risk mitigation actions and appoint risk owners. The risk owners are responsible to implement, and the senior management is responsible to monitor the effectiveness of the risk mitigation actions.

The Board, through the Audit Committee, has conducted a review of effectiveness on both design and implementation of the risk management and internal control systems of the Group for the year ended 31 December 2024, covering all material controls, including financial, operational and compliance controls. Such review will be made at least annually to monitor the adequacy and the effectiveness of the risk management and the internal control system of the Group. In this respect, the Audit Committee communicates any material issues to the Board.

## 風險管理及內部控制

董事會知悉其職責為持續監督本集團風險管理及內部控制 系統及檢討其效力。

本集團已制定批准及控制開支之指引及程序,旨在確保財務報告的可靠性、運營效益及效率以及遵守適用法律及法規。儘管該等指引及程序旨在識別與管理可能對本集團實現業務目標有不利影響的風險,但提供合理(而非絕對)保證避免重大失實陳述、錯誤、損失、詐騙或違規。

本集團設計內部控制及風險管理系統以保障本集團的資產 及股東權益。本集團已設立風險管治程序以識別、評估及 管理風險(包括與各營運部門相關的環境、社會及風險)。 營運部門負責識別及評估可能影響本集團業務運作及目標 的潛在風險。高級管理層隨後根據風險的潛在影響及發生 機率評估該等潛在風險。經高級管理層評估後識別出的風 險被納入風險登記冊,並製定風險緩解措施及指定風險負 責人。風險負責人負責執行,而高級管理層則負責監察風 險緩解措施的成效。

董事會透過審核委員會曾對本集團截至二零二四年十二月 三十一日止年度的風險管理及內部控制系統的設計及執行 功效曾進行檢討,範圍覆蓋所有重大控制措施,包括財務、 營運及合規控制。就監督本集團風險管理及內部控制系統 的充足性及效力之檢討將最少每年進行一次。在此方面, 審核委員會向董事會匯報任何重大事宜。

Although the Company does not have internal audit function due to relatively simple corporate structure, size and complexity, the Board has put in place adequate measures to perform the internal audit function at different aspects of the Group. The Group reviews the need for internal audit function annually, and has engaged CT Partners Consultants Limited ("CT Partners") to review the effectiveness and efficiency of the Group's risk management and internal control systems in relation to the financial, operational and compliance controls for the year ended 31 December 2024, and the results of the independent review and assessment from CT Partners were summarised and reported to the Audit Committee and the Board. No significant area of concern that may affect the financial, operational, compliance, control and risk management of the Group has been identified.

Moreover, improvements in internal control and risk management measures as recommended by CT Partners to enhance the risk management and internal control systems of the Group and mitigate risks of the Group were adopted by the Board. Based on the findings and recommendations of CT Partners as well as the comments of the Audit Committee, the Board considered the internal control and risk management systems effective and adequate.

# ANTI-CORRUPTION POLICY AND WHISTLEBLOWING POLICY

The Group has established anti-fraud and anti-money laundering policy that promote and support anti-corruption laws and regulations, and set out measures for employees, suppliers and business partners to raise concerns, in confidence and anonymity, with the audit committee of the Company about possible improprieties in any matter related to the Group.

## INSIDE INFORMATION POLICY

With respect to the monitoring and disclosure of inside information, the Group has adopted a policy on disclosure of inside information with the aim to ensure the insiders are abiding by the confidentiality requirement and are fulfilling the disclosure obligation of the inside information.

The policy provides guidelines on the reporting system and handling procedures of potential inside information. Before the information is fully disclosed to the public, the Group ensures the information is kept strictly confidential. Only designated staff are allowed to access the inside information. Information contained in announcements are reviewed and approved by the senior management of the Group to ensure that no false or misleading information presents. In case the Group believes that the necessary degree of confidentiality cannot be maintained or that confidentiality may have been breached, the Group would disclose the information to the public as soon as reasonably practicable.

此外,董事會已採納CT Partners提出的改善內部控制及風險管理措施的建議,以提升本集團的風險管理及內部控制系統及降低本集團的風險。根據CT Partners的結論及建議以及審核委員會的意見,董事會認為內部控制及風險管理系統屬有效及適當。

Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

# PROCEDURES FOR PUTTING FORWARD PROPOSALS AT SHAREHOLDERS' MEETING

Shareholders are requested to follow Article 64 of the Articles for putting forward a resolution at an extraordinary general meeting. The requirements and procedures are set out above in the section headed "Procedures for Convening General Meetings by Shareholders" in this annual report.

Pursuant to Article 113 of the Articles, no person, other than a retiring Director, shall, unless recommended by the Board for election, be eligible for election to the office of Director at any general meeting, unless notice in writing of the intention to propose that person for election as a Director and notice in writing by that person of his willingness to be elected shall have been lodged at the Company's principal place of business or branch share registrar and transfer office in Hong Kong. The period for lodgment of the notices required under Article 113 will commence no earlier than the day after the despatch of the notice of the general meeting appointed for such election and end no later than fourteen days prior to the date of such general meeting and the minimum length of the period during which such notices to the Company may be given will be at least fourteen days.

## INTRODUCTION

Geotech Holdings Ltd. and its subsidiaries (the "Group", "we", or "our") are primarily engaged in civil engineering and construction services based in Hong Kong. Our principal operating subsidiary, Geotech Engineering Limited, specializes in both private and public works related to landslip prevention and remedial work for slopes or retaining walls. As part of our commitment to sustainability, we are pleased to present our Environmental, Social, and Governance ("ESG") Report for the year ended 31 December 2024 (the "Review Year"). This report highlights our Group's ESG performance and initiatives, focusing on our core business area of construction and engineering services in Hong Kong, in line with the scope of the previous year's reporting. Through this report, we aim to provide transparency on our sustainable business practices, demonstrating our dedication to addressing key environmental and social challenges in the industry.

The ESG Report has been prepared in accordance with the ESG Reporting Guide set out in Appendix C2 of the Rules Governing the Listing of Securities ("**Listing Rules**") on the Stock Exchange of Hong Kong Limited and adheres to the "comply or explain" provisions. This ensures that our reporting is comprehensive and aligned with the evolving expectations of our stakeholders while highlighting the areas where we can continue to make meaningful improvements.

The Group is committed to operating sustainably and delivering premium services, and we strictly adhere to the principles of materiality, quantitative, and consistency in reporting our relevant measures and performance.

#### **BOARD STATEMENT**

The Group integrates ESG considerations into our business strategy and decision-making processes. To achieve this, we have developed a comprehensive governance structure that ensures the segregation of duties in our ESG management, covering personnel at all levels — high, middle, and low.

The ultimate responsibility for overseeing the Group's ESG-related risks, opportunities, and performance lies with the Board of Directors (the "Board"). The Board is responsible for setting the Group's ESG-related strategies, targets, and long-term objectives. It regularly reviews the Group's ESG performance against established targets and revises strategies when necessary, particularly in response to significant deviations or emerging issues. Additionally, the Board ensures that all ESG risks are adequately identified, mitigated, and aligned with the Group's broader sustainability goals, while overseeing the continuous improvement of ESG practices within the Group.

Supporting the Board in executing ESG-related strategies, a dedicated ESG working group has been established. This group includes representatives from key operational departments, such as finance, safety, environmental, and administration, ensuring a crossfunctional approach to ESG management. The ESG working group is responsible for coordinating the integration of ESG factors into day-to-day operations, aligning all business activities with the Group's ESG objectives, and regularly reporting to the Board on the progress of initiatives. The ESG working group is also tasked with collecting relevant ESG data from each functional department, monitoring the execution of ESG measures, and identifying any deviations from set targets. They ensure that corrective actions are taken when required to address any shortcomings in ESG performance. Regularly reviewing ESG performance ensures that the Group remains on track to meet its long-term sustainability objectives.

Bi-annual meetings are held between the Board and the ESG working group to review the progress of ESG strategies, evaluate target achievements, and ensure alignment with the Group's objectives. In these meetings, the Board and the ESG working group also discuss emerging ESG risks and opportunities, assess the effectiveness of current measures, and make adjustments to improve overall performance. The ESG working group is responsible for ensuring that all relevant stakeholders, both internal and external, are kept informed of ESG-related developments and for promoting a culture of accountability across the Group.

With a deep understanding of ESG risks and opportunities, the Group is better equipped to allocate resources effectively, make informed business decisions, and drive sustainable growth. The Group continuously assesses its ESG performance to adapt to changing conditions and ensures that all ESG initiatives contribute to the long-term success of the business.

#### **MATERIALITY ANALYSIS**

The Group believes that conducting a materiality assessment helps prioritize the most pressing ESG issues, enabling us to integrate them into our strategy and ensuring sustainable value creation for all stakeholders.

To ensure a systematic and robust approach, the Group follows a structured materiality assessment process with multiple stages to identify material ESG issues. First, the Group compiles a list of ESG issues and stakeholders potentially relevant to our business, including, but not limited to, governance practices, environmental impacts, social concerns, and industry-specific issues. Next, we engage with key stakeholders to collect their views on the most important ESG topics and carefully review their feedback.

The identified ESG issues are then rated based on their relevance to the business and stakeholders, as well as their respective level of impact. We consider both the significance of the issue to stakeholders and its alignment with the Group's strategy, operations, and risk management processes, prioritizing them by taking into consideration their short-term and long-term effects on the Group's operations and sustainability goals. Material ESG topics are then filtered and used as a guiding framework for our ESG efforts.

The Group then develops specific strategies, targets, and action plans to address the identified material ESG issues, allowing for more comprehensive, transparent, and targeted responses. Finally, we conduct regular reviews of the materiality assessment process to ensure it remains up-to-date and reflects changes in the business environment, stakeholder expectations, and emerging ESG trends.

The material ESG issues have been identified as follows:

#### 重要性分析

本集團相信,進行重要性評估有助優先處理最緊迫的環境、 社會及管治事宜,使我們能夠將其納入戰略,並確保為所 有持份者創造可持續的價值。

為確保有系統且穩健的方法,本集團遵循結構化的重要性評估流程,分階段識別重要的環境、社會及管治事宜。首先,本集團編制一份可能與我們業務相關的環境、社會及管治事宜及持份者清單,包括但不限於治理常規、環境影響、社會關注及行業特定議題。接著,我們與主要持份者溝通,以收集彼等對最重要的環境、社會及管治議題的意見,並仔細審視彼等的反饋。

所識別的環境、社會及管治事宜隨後根據其與業務和持份者的相關性以及其各自的影響程度進行評級。我們考慮有關事宜對持份者的重要性,及與本集團策略、營運及風險管理流程的一致性,並根據其對本集團營運及可持續發展目標的短期和長期影響進行優先排序。我們其後篩選出重要的環境、社會及管治議題,並用作我們環境、社會及管治工作的指導框架。

本集團隨後制定具體策略、目標及行動計劃,以應對所識別的重要環境、社會及管治事宜,從而提供更全面、透明及針對性的回應。最後,我們定期檢討重要性評估過程,以確保其與時並進,並反映營商環境、持份者期望及新興環境、社會及管治趨勢的變化。

#### I. ENVIRONMENTAL

#### I.1 Our environmental policy

To ensure responsible environmental management across our engineering and construction operations, we have established a Safety and Environmental Department, which is responsible for ensuring the Group's full compliance with environmental protection regulations. This department comprises environmental management professionals who continuously monitor market trends, statutory requirements, internal policies, and safety and environmental measures. Whenever there are changes or updates to statutory and industry requirements, we promptly revise our internal work procedures and policies to ensure compliance. Through these proactive measures, we strive to mitigate risks, enhance efficiency, and drive sustainability across our business activities.

In addition, we have developed an Environmental Management Plan ("EM Plan") as our organizational framework. The EM Plan defines the duties and responsibilities of our environmental management functions, aiming to prevent harm to the environment. As part of this framework, an environmental management team is established for each project, consisting of a Site Safety & Environmental Committee and a Site Safety & Environmental Management Committee. These committees regularly assess and monitor the implementation of site safety and environmental measures to ensure compliance with the Group's requirements.

The EM Plan undergoes periodic reviews and updates to align with evolving environmental standards. Any revisions are promptly communicated to all employees and subcontractors through internal memos and discussed in regular meetings. Additionally, we conduct weekly environmental inspections to proactively identify and mitigate potential environmental nuisances.

Our environmental policies focus on the following key objectives:

- Ensuring strict compliance with all relevant environmental laws and regulations;
- Preventing operational activities from negatively impacting the environment or public health;
- Managing our supply chains effectively by incorporating environmental protection initiatives into supplier and subcontractor selection criteria;
- Being open and responsive to stakeholders' environmental expectations and concerns; and
- Allocating adequate resources and facilities for environmental nuisance abatement, waste management, and pest control management.

#### 1、 環境

#### I.1 我們的環境政策

為確保我們的工程及建築業務負責任的環境管理,我們已成立安全及環境部門,負責確保本集團全面遵守環境保護法規。該部門由環境管理專業人員組成,彼等持續監察市場趨勢、法定要求、內部政策以及安全和環境措施。每當法定和行業要求有變更或更新時,我們會即時修訂內部工作程序和政策,以確保合規。透過該等積極措施,我們致力降低風險,提高效率,並推動業務活動的可持續發展。

此外,我們已制定環境管理計劃作為我們的 組織框架。環境管理計劃訂明我們環境管理 職能的職責及責任,旨在防止對環境造成損 害。作為此框架的一部分,每個項目均設立一 個環境管理團隊,由地盤安全及環境委員會 以及地盤安全及環境管理委員會組成。該等 委員會定期評估和監察地盤安全及環境措施 的實施情況,以確保符合本集團的要求。

環境管理計劃定期進行審查及更新,以符合不斷變化的環境標準。任何修訂均會透過內部備忘錄迅速傳達予全體僱員及分包商,並定期開會討論。此外,我們每週進行一次環境監測,以主動識別及減輕潛在的環境損害。

我們的環境政策著重於以下主要目標:

- 確保嚴格遵守所有相關環境法律及法規;
- 防止營運活動對環境或公眾健康造成負面影響;
- 進行有效的供應鏈管理,將環境保護措施納入供應商和分包商的甄選標準;
- · 接受及回應持份者對環境的期望及關切; 及
- 分配充足的資源及設施以實施減少對環境造成滋擾、廢棄物管理及害蟲防治管理的措施。

# Minimising impact of our operations to the environment and natural resources

We fully recognise that our construction and engineering operations inevitably impact the environment, including air and water pollution, waste generation, and resource consumption. Understanding these potential environmental risks, we have developed and implemented comprehensive environmental policies and procedures to minimize our ecological footprint. Our staff and subcontractors are required to strictly adhere to these guidelines, ensuring that all site activities comply with environmental regulations and industry best practices. Through continuous training, regular monitoring, and the enforcement of mitigation measures, we strive to operate responsibly — reducing environmental harm while integrating sustainable practices into every project we undertake.

All work procedures carried out by our employees and subcontractors must comply with our established policies and procedures, which are accredited under ISO 9001:2015 for Quality Management Systems and ISO 14001:2015 for Environmental Management Systems. This ensures that our operations align with sustainability principles and maintain high environmental and quality standards. To uphold compliance, weekly or monthly environmental inspections are conducted at construction sites to identify any instances of non-compliance. If issues are detected, corrective action plans are promptly implemented to mitigate environmental risks, ensure adherence to regulations, and continuously improve our environmental performance.

#### **Air Pollution Control**

As a construction-focused company, we acknowledge that certain activities inevitably contribute to air pollution, which can impact the surrounding environment. To minimize these effects, our on-site project teams implement stringent dust control measures during high-dust activities, such as demolition, drilling, and excavation of rock or artificial hard materials, particularly in areas near the public. These measures include water spraying, the use of vacuum cleaning devices, and the proper covering or sheltering of dusty materials, all subject to approval by the registered engineer onsite. Additionally, to reduce gaseous emissions — such as black smoke or fumes — generated by construction equipment, we enforce strict emission control measures to ensure compliance with air quality standards. This includes using construction machinery and vehicles that comply with emission standards and implementing policies to switch off engines when machinery and vehicles are not in use to reduce unnecessary emissions.

#### **Wastewater Management**

Although our site operations generate only minimal amounts of wastewater, we remain committed to implementing effective wastewater pollution abatement measures. Proper site management prevents surface runoff from washing across the site and spilling into surrounding areas. All wastewater is directed to designated treatment facilities before discharge, ensuring compliance with environmental protection standards and preventing land pollution. By proactively managing wastewater disposal, we safeguard the environment and uphold our commitment to responsible construction practices.

#### 減少我們的業務對環境及自然資 源的影響

我們充分認識到,我們的建築及工程業務不可避免地對環境產生影響,包括空氣和水污染、廢棄物產生以及資源消耗。了解這些潛在的環境風險後,我們已制定並實施全面的環境政策和程序,以將我們的生態足跡降至最低。我們的員工和分包商必須嚴格遵守這些指引,確保所有現場活動符合環境法規和行業最佳常規。通過持續培訓、定期監控和執行緩解措施,我們致力以負責任的方式營運,在減少環境危害的同時,將可持續發展常規融入我們承接的每個項目中。

我們的僱員及分包商所執行的所有工作程序必須符合我們已建立的政策及程序,該等政策及程序已獲ISO 9001:2015質量管理體系及ISO 14001:2015環境管理體系認證。此舉確保我們的營運符合可持續性原則,並維持高環境及質量標準。為了維持合規,每週或每月於施工工地進行環境檢查,以識別任何不合規情況。倘若發現問題,將迅速實施糾正行動計劃,以減輕環境風險,確保遵守規例,並持續改善我們的環境表現。

#### 空氣污染管制

#### 廢水管理

儘管我們的工地營運產生的廢水量極少,我們仍然致力實施有效的廢水污染減排措施。 妥善的地盤管理可防止水流流過地盤或溢出 地盤周邊地區。所有廢水在排放前均被導入至 指定的處理設施,確保符合環境保護標準並 防止土地污染。透過積極管理廢水處理,我們 保護環境並堅守我們對負責任建築常規的承諾。

#### Waste handling

In managing waste, we adhere to a structured framework known as the "Waste Management Hierarchy," which consists of four key steps: "Avoidance and Minimization," "Re-use," "Recover and Recycle," and "Treatment and Disposal." helps the Group reduce waste generation, conserve resources, minimize environmental impact, and contribute to a more sustainable and circular economy. To ensure effective waste management, we have established specific targets and require all employees to strictly follow them whenever feasible.

#### Avoidance and Minimization:

The best way to reduce waste is by preventing it from being created. By planning better, purchasing wisely, and improving processes, we can significantly reduce waste. This helps conserve resources and lowers disposal needs.

#### Example:

 Using water-based finishing materials to minimize environmental harm, reusing wood packaging for formwork purposes to reduce the need for new materials, and employing recyclable containers for fixtures and fittings to promote sustainability and minimize waste.

#### Re-use:

Reusing materials before disposal extends their life, reduces the need for new materials, and cuts waste. It helps conserve resources, save energy, and lower the environmental impact of construction.

#### Examples:

- Excavated Material: All excavated materials or pure construction and demolition inert materials (such as hard rock, sand, soil, and broken concrete) are sorted on-site for reuse before disposal to designated outlets, like the Public Fill Reception Facility.
- Repurposing hard standing and old bricks for continued use.
- Diverting waste to other construction sites for reuse where possible.

#### 廢棄物處理

在管理廢棄物時,我們遵循「廢棄物管理分級」的結構化框架,該框架由四個關鍵步驟組成:「避免和減少廢棄物產生」、「再利用」、「回收及循環再造」及「處理及棄置」,有助集團減少廢棄物產生、節約資源、減少對環境的影響,並促進更可持續和循環的經濟。為確保有效的廢棄物管理,我們已制定具體目標,並要求所有員工在可行的情況下嚴格遵守。

#### 1. 避免和減少廢棄物產生:

減少廢棄物的最佳方法是防止廢棄物 的產生。通過更完善的規劃、明智的採 購和改進流程,我們可以大幅減少廢棄 物,有助節約資源並降低處置需求。

#### 例如:

使用水性飾面材料以減少環境危害,於模板中重複使用木制包裝以減少對新材料的需求,以及為固定裝置及配件採用可回收容器,以促進可持續發展及減少廢棄物。

#### 2. 再利用:

在棄置前再利用材料可以延長其壽命,減少對新材料的需求,並減少廢棄物, 有助節約資源、節省能源,並降低建築 對環境的影響。

#### 例如:

- 挖出物:所有挖出物或純建築及 拆卸惰性材料(例如硬石、沙、 土及混凝土碎塊)在地盤分類以 便重複使用,然後才向指定地點 (如公眾填料接收設施)棄置。
- 重複使用可重用的硬面層及舊磚。
- 盡可能將廢棄物轉移至其他施工工地進行再利用。

#### 3. Recover and Recycle:

Recycling turns waste into new products, reducing the need for new materials and saving energy. It helps keep waste out of landfills, lowers greenhouse gas emissions, and supports a circular economy where materials are reused.

#### Examples:

- Metal waste is sorted and recovered on-site, then collected by recycling contractors for proper recycling.
- Demolition debris, including broken concrete, reinforcement bars, mechanical fittings, and other hardware, is sorted onsite for recovery and sent to established recycling outlets.

#### 4. Treatment and Disposal:

Although it's the last option, proper waste treatment and disposal are still needed for waste that can't be avoided, reused, or recycled. This ensures harmful substances are safely managed, preventing soil, air, and water contamination and reducing health risks.

#### Examples:

- Cardboard and paper packaging, used for plant, equipment, and materials, are sorted on-site and stockpiled properly in a dry condition to prevent cross-contamination with other waste materials.
- All chemical waste is collected and disposed of by licensed contractors, ensuring compliance with environmental regulations.

During the Review Year, to the best of the Group's knowledge, we did not have any non-compliance issues in relation to environmental laws and regulations in Hong Kong regarding air and greenhouse gas emissions, discharges into water and land and generation of hazardous and non-hazardous waste.

#### 3. 回收及循環再造:

回收將廢棄物轉化為新產品,減少對新 材料的需求並節省能源,有助減少垃圾 堆填區的廢棄物,降低溫室氣體排放, 並支持材料重用的循環經濟。

#### 例如:

- 金屬廢棄物在地盤分類及回收, 然後由回收承包商收集以進行適 當的回收。
- 拆卸碎片,包括混凝土碎塊、鋼筋條、機械裝置及其他硬件,會在地盤分類以回收並送往既定的回收地點。

#### 處理及棄置:

儘管處理及棄置是最後的選擇,但對於無法避免、再利用或循環再造的廢物,仍然需要進行適當的廢棄物處理及棄置,確保有害物質得到安全管理,防止 十壤、空氣和水污染,並降低健康風險。

#### 例如:

- 用於廠房、設備及材料的硬紙板及紙質包裝,會在地盤分類並在乾燥條件下適當儲存,以防止與其他廢棄物材料交叉污染。
- 所有化學廢棄物均由持牌承包商 收集及處置,確保遵守環境法規。

於回顧年度內,就本集團所深知,我們並無任何與香港環境法例法規有關涉及空氣及溫室氣體排放、水及土地的排污以及產生有害及無害廢棄物的不合規問題。

#### I.2 Greenhouse gas ("GHG") emissions

During the Review Year, the Group's primary sources of emissions continued to be motor vehicle usage for transportation between project sites and purchased electricity. Due to longer project durations and the expansion into larger, more complex sites, emissions from vehicle use increased slightly. Recognizing that GHG emissions are a major driver of climate change, the Group remains committed to minimizing its environmental impact and enhancing sustainability.

To address these emissions, we have implemented a series of carbon reduction measures focused on vehicle management, including:

- Closely monitoring fuel consumption in all company vehicles to prevent wastage;
- Prioritizing the procurement of environmentally friendly vehicles, taking into account their weight and fuel efficiency;
- Conducting regular maintenance to ensure engines operate at peak efficiency;
- Using fuel that complies with the Air Pollution Control Ordinance, limiting sulfur content to a maximum of 0.005%; and
- Enforcing strict policies to prevent idling vehicles.

As part of our broader sustainability strategy, we have successfully achieved the target set in the previous year to reduce GHG emissions by 10% from the 2021 baseline by 2026. In the coming year, we aim to further reduce total GHG emissions for Scope 1 and Scope 2 while maintaining the same level of construction activity and staff size. To achieve this, we will continue optimizing driving routes between construction sites and gradually transition to electric vehicles.

#### I.2 溫室氣體排放

於回顧年度,本集團的主要排放來源仍為使 用汽車進行項目工地之間的運輸及所購電力。 由於項目持續時間延長及擴展至更大、更複雜 的地盤,車輛使用所產生的排放量略有增加。 本集團認識到溫室氣體排放為氣候變化的主 要推動力,繼續致力減少其對環境的影響並 提升可持續性。

為應對該等排放問題,我們已實施一系列專 注於車輛管理的減碳措施,包括:

- 密切監控所有公司車輛的燃料消耗以防止浪費;
- 優先考慮採購環保車輛,並考慮其重量 及燃油效率;
- 定期進行維護,以確保引擎在最佳效率 下運行;
- 根據《空氣污染管制條例》,使用含硫量不超過0,005%的燃料;及
- 嚴格執行政策以防止空轉車輛。

作為我們更廣泛的可持續發展策略的一部分, 我們成功達成在上年度設定的目標,即在二 零二六年前將溫室氣體排放量從二零二一年 的基線減少10%。於來年,我們的目標是進一 步減少範疇 1 及範疇 2 的總溫室氣體排放,同 時保持相同的建設活動水平及員工規模。為 達成此目標,我們將繼續優化施工工地之間 的駕駛路線,並逐步過渡至電動車輛。

Purchased electricity is another significant source of the Group's emissions. To minimize our carbon footprint, we have implemented a series of energy-saving measures to maintain the lowest possible consumption levels. However, despite these efforts, electricity usage increased during the Review Year due to the complexity and larger scale of construction sites, which required higher energy consumption. For further details, please refer to the "Use of Resources" section.

Through these ongoing initiatives, the Group continues to strengthen its commitment to sustainability and contribute to climate change mitigation.

The following presents our GHG emissions key performance indicators ("KPI") for the Review Year:

The Group does not generate hazardous waste in its operations; therefore, setting a reduction target for hazardous waste is not applicable. However, non-hazardous waste, primarily construction waste, was generated during the Review Year and managed in compliance with the Environmental Protection Department's regulations.

本集團的營運並無產生有害廢棄物,因此設定 減少有害廢棄物的目標並不適用。然而,於回 顧年度內產生的無害廢棄物主要為建築廢料, 其乃按照環境保護署的規定進行管理。

For the coming year, we have set a conservative target to stabilize non-hazardous waste intensity at a level not more than 10% higher than the Review Year. To achieve this, we will enhance material planning to minimize excess use, strengthen on-site waste sorting and recycling initiatives, and explore opportunities to reuse inert materials wherever feasible.

於來年,我們設定一個保守的目標,將無害廢棄物的密度穩定維持於不高於回顧年度10%的水平。為實現此目標,我們將加強物料規劃以減少過量使用,強化現場廢棄物分類及回收計劃,並探索在可行的情況下重用惰性材料的機會。

#### I.3 Use of Resources

The Group is committed to optimizing resource use, with a strong focus on critical resources like electricity, water, and paper. We motivate our employees to minimize their environmental impact by actively reducing energy consumption and making the most of available resources. The following outlines the main initiatives we have adopted in these areas:

#### Electricity

We have implemented several energy-saving measures across both office and project sites to demonstrate our commitment to energy efficiency, including:

- Placed near air conditioning switches to remind staff to set the temperature at an energy-efficient 25°C.
- Encouraging staff to turn off lights, machinery, and office equipment when not in use.
- Conducting regular checks and maintenance of air-conditioning systems to ensure optimal operation and prevent breakdowns.
- Providing educational sessions to employees on energy-saving practices and encouraging their active participation in conservation efforts.

In the coming year, we will continue to set a target to reduce electricity usage intensity by optimizing the use of electric devices and appliances, purchasing energy-efficient equipment, and regularly cleaning airconditioning filters to improve cooling efficiency.

#### Water

While we have no challenges in sourcing water, we remain committed to promoting water conservation across our operations. As water usage depends on the scope and nature of work at project sites, setting specific targets for water efficiency is not applicable. However, we continue to raise awareness by placing reminders next to water taps to encourage employees to conserve water.

#### I.3 資源利用

本集團致力優化資源利用,並將重點放在電力、用水及紙張等關鍵資源上。我們鼓勵員工積極減少能源消耗,充分利用可用資源,從而盡量減少對環境的影響。以下概述我們於該等領域採取的主要措施:

#### 電力

我們已在辦公室及項目工地實施多項節能措施,以展示我們對能源效率的承諾,包括:

- 於空調開關附近放置標籤,以提醒員工 將溫度設定在攝氏二十五度的節能水平。
- 鼓勵員工在不使用時關閉電燈、機器及 辦公設備。
- 定期檢查及維護空調系統,以確保最佳 運行並防止故障。
- 為員工提供有關節能常規的教育課程, 並鼓勵彼等積極參與節能工作。

於來年,我們將繼續設定目標,通過優化電力 裝置及電器的使用、購買節能設備,以及定期 清潔空調濾網以提高冷卻效率,從而減少用 電密度。

#### 用水

儘管我們在求取水源方面並無遇到任何挑戰,然而我們仍然致力在業務營運中推廣節約用水。由於用水量取決於項目工地工程的範圍和性質,因此設定具體的用水效率目標並不適用。然而,我們繼續透過在水龍頭旁放置提醒標語來提高員工的節水意識。

#### **Paper**

We have implemented a series of initiatives aimed at reducing paper usage and minimizing our ecological footprint:

- Utilizing digital presentations and note-taking during meetings to eliminate the need for printed handouts and meeting minutes.
- Reusing old envelopes for internal communication and drafts.
- Preferring electronic communication over printed materials whenever possible.
- Purchasing paper products made from recycled materials and certified sustainable sources.

#### **Packaging Materials and Other Initiatives**

The Group does not utilize packaging materials in its operations, and therefore, disclosure of such data is not relevant. However, we actively promote sustainable practices among our staff:

- Encouraging employees to bring their own lunches to reduce the use of single-use foam lunch boxes typically associated with takeout meals.
- Advocating for mindful consumption to minimize food waste, with reminders to staff to order only what they can consume and reduce over-ordering.

Through these initiatives, we foster a culture of sustainability within the organization and encourage responsible choices that align with our environmental values. We advocate for mindful consumption habits to minimize waste across all areas.

#### 紙張

我們已實施一系列措施旨在減少紙張使用及 盡量減少我們生態足跡:

- 在會議中利用數字展示和記錄工具,以 省去對印刷講義和會議記錄的需求。
- 重用舊信封作內部溝通及草稿用途。
- 在可行的情況下,優先選擇電子溝通而 非列印材料。
- 採購由回收材料及經認證的可持續來源 製成的紙品。

#### 包裝材料及其他措施

本集團業務不使用包裝材料,因此有關數據 的披露並不相關。然而,我們積極向員工推廣 可持續常規:

- 鼓勵員工自備午餐,以減少使用外賣餐 點通常使用的一次性泡沫午餐盒。
- 提倡有意識的消費以減少食物浪費,並 提醒員工僅訂購彼等能夠消耗的食物, 減少過量訂購。

透過該等措施,我們在組織內培養可持續發展的文化,並鼓勵符合我們環境價值觀的負責任選擇。我們提倡有意識的消費習慣,以減少各個領域的浪費。

During the Review Year, the increase in water and diesel consumption was primarily due to the higher demand for both resources across larger and more complex project sites.

#### I.4 Climate change

Climate change is one of the most crucial issues of the past decade. The Group performs ongoing assessments of potential climate-related risks to understand the risks we may encounter and their potential impacts on the Group.

#### **Physical Risks**

Risk Description:

Flooding: Flooding poses a significant risk, particularly in areas prone to heavy rainstorms. It can disrupt construction and engineering activities, causing delays and hazards to workers' safety. Additionally, flooding may damage equipment and infrastructure on-site.

Typhoons or Heavy Rainstorms: Typhoons and heavy rainstorms present acute risks that can cause significant disruption to construction activities. These weather events may lead to unsafe working conditions, especially in terms of worker safety, equipment damage, and project delays.

High Temperature: Extreme heat can affect worker safety and health, leading to heat-related illnesses and reduced productivity.

Risks response:

Flooding: Our offices and site offices are strategically located outside highrisk flooding areas. To ensure the safety of our staff and workers, we have established clear policies for severe weather conditions, which must be followed during such events.

Typhoons or Heavy Rainstorms: In the event of an approaching typhoon or heavy rainstorm, staff are required to inspect all site facilities, drainage channels, and manholes to ensure they are free of silt and debris. We also implement intercepting channels along the edges of excavations to prevent surface runoff across excavation faces and exposed soil. Additionally, we maintain a large and diverse supplier base, enabling us to source materials from alternative suppliers in case of disruptions caused by extreme weather conditions.

High Temperatures: To protect workers from high temperatures, we ensure adequate supplies of water and provide shaded rest areas where workers can cool down and take breaks.

#### I.4 氣候變化

氣候變化是過去十年中最重要的議題之一。 本集團持續評估潛在氣候相關風險,以了解 我們可能面臨的風險及其對本集團的潛在影響。

#### 實體風險

風險描述:

水災:水災構成重大風險,尤其是在容易遭受 暴雨侵襲的地區,可能會擾亂建築及工程活動,導致延誤並對工人的安全構成危險。此外,水災可能會損壞工地的設備和基礎設施。

颱風或暴雨:颱風和暴雨帶來嚴重風險,可能 對施工活動造成重大干擾。這些天氣事件可能 導致不安全的工作環境,特別是在工人安全、 設備損壞和項目延誤方面。

高溫:極端高溫可能影響工人的安全和健康, 導致與高溫相關的疾病和生產力下降。

#### 風險應對:

水災:我們的辦公室和工地辦公室策略性地 設置在高風險水災區域之外。為確保我們的 員工及工人的安全,我們已制定明確的惡劣 天氣政策,員工及工人必須在相關情況下遵 守該等政策。

颱風或暴雨:如遇颱風或暴雨來襲,員工須檢查所有地盤設施、排水渠道及沙井,以確保無淤泥及碎片。我們亦沿挖掘邊緣設置攔截渠道,以防止水流流過挖掘面及表土。此外,我們維持一個龐大且多元化的供應商網絡,使我們能夠在極端天氣狀況導致中斷的情況下,從其他供應商採購材料。

高溫:為保護工人免受高溫侵襲,我們確保充 足的水供應,並設置陰涼的休息區,讓工人可 以降溫和休息。

#### **Transition Risks**

#### Risk Description:

Customer Preference Shift: There is a growing trend where customers are increasingly favoring service providers that have a smaller environmental impact, particularly those who contribute less to climate change. This shift in customer preferences could pose a transition risk to the Group, as it might affect demand for our services if we are unable to meet evolving environmental expectations.

Regulatory Changes: Changes in climate-related regulations may also create transition risks. As governments implement stricter environmental laws and policies, there could be an impact on how construction and engineering companies operate. The Group is aware that such regulations may require modifications to existing processes, equipment, or materials, potentially affecting our cost structure and operational procedures.

#### Risks response:

Customer Preference: The Group does not anticipate significant adverse effects from the shift in customer preferences in the near future due to our specialized nature of work. We continue to monitor market trends and customer expectations to ensure that our services remain aligned with the evolving demand for environmentally conscious solutions.

Regulatory Monitoring: To address potential regulatory changes, the Group actively monitors the regulatory landscape related to climate change and environmental standards. This includes keeping track of local and international climate-related laws and regulations. By staying informed, we can adjust our services and operations accordingly to ensure compliance and avoid potential disruptions.

The Group continues to monitor climate-related risks and has implemented relevant measures to minimize potential physical and transition risks, although extreme weather conditions and changes in climate-related regulations are not expected to materially affect the Group's operations in the near future.

#### 過渡風險

#### 風險描述:

客戶偏好轉變:客戶越來越傾向選擇對環境 影響較小的服務供應商,尤其是那些對氣候 變化影響較小的供應商,此趨勢正在增長。客 戶偏好轉變可能對本集團構成過渡風險,因 為如果我們無法滿足不斷變化的環境期望, 可能會影響對我們服務的需求。

監管變動:氣候相關法規的變動亦可能造成 過渡風險。隨著政府實施更嚴格的環境法律 和政策,可能會影響建築及工程公司的運作 方式。本集團知悉此類法規可能需要對現有 流程、設備或材料進行修改,可能影響我們的 成本結構及營運程序。

#### 風險應對:

客戶偏好:由於我們工作的專業性質,本集團預期近期內客戶偏好轉變不會造成重大不利影響。我們持續監察市場趨勢及客戶期望,以確保我們的服務能夠符合日益增長的環保解決方案需求。

監管監察:為應對潛在的監管變動,本集團積極監察與氣候變化及環境標準相關的監管環境,包括追蹤本地及國際氣候相關法律及法規。通過隨時掌握資訊,我們可以相應調整服務及營運,以確保合規並避免潛在作業中斷。

儘管極端天氣狀況及氣候相關法規的變化預計不會在近期對本集團的營運產生重大影響, 本集團將繼續監察氣候相關風險,並已採取 相關措施以將潛在的物理及過渡風險降至最低。

#### II. SOCIAL

#### **II.1 Employment and Labour Practices**

The Group highly values its employees and places great emphasis on effective human resources management to ensure the organization attracts and retains top talent.

#### **Recruitment and Talent Acquisition**

To attract skilled professionals, we offer competitive remuneration packages tailored to each individual's position, qualifications, and experience level. Our Human Resources & Administrative Department ensures that rigorous controls are in place during the recruitment process to align candidates with the Group's needs and prevent any unlawful practices. We hire based solely on a candidate's suitability and abilities, without regard to gender, religion, nationality, or other irrelevant factors. Our recruitment process is designed to identify individuals with the necessary skills, qualifications, and experiences required for the job, promoting a diverse and inclusive workplace where all employees are valued and respected.

#### Policy on Child and Forced Labor

The Group maintains a zero-tolerance approach towards child labor and the hiring of illegal immigrants, both in the office and on construction sites. Stringent recruitment controls are implemented to prevent such illegal practices. In the event of any discrepancies, such as mismatched ages or identities, the Group immediately terminates employment with the concerned individual. Furthermore, forced labor is strictly prohibited across all operations.

#### **Employee Welfare and Compensation**

To safeguard employees' rights, the Group has established comprehensive staff handbooks and employment policies covering compensation, promotions, working hours, rest periods, and other welfare measures. We regularly review compensation and benefits programs to ensure they remain competitive and meet the needs of our workforce.

Through effective staff appraisals and communication, exceptional employees are recognized, rewarded, and given opportunities for internal promotion and salary increases. This system helps to ensure that high-performing staff are appropriately valued and incentivized.

#### Ⅱ、社會

#### Ⅱ.1 僱傭及勞工常規

本集團高度重視其僱員,並非常重視有效的 人力資源管理,以確保組織能夠吸引及挽留 頂尖人才。

#### 招聘及人才招募

為吸引技術專業人士,我們提供根據每位個人的職位、資歷及經驗水平量身訂做的具競爭力薪酬待遇。我們的人力資源及行政部門確保在招聘過程中實施嚴格的控制措施,以使候選人符合集團的需求並防止任何非法行為。我們僅根據候選人的適合性和能力進行聘用,並不考慮性別、宗教、國籍或其他不相關的因素。我們的招聘程序旨在識別具備工作所需技能、資格和經驗的個人,促進一個多元和包容的工作環境,使所有員工都受到重視和尊重。

#### 有關童工及強迫勞工的政策

無論是在辦公室或施工工地,本集團對童工 及僱用非法移民採取零容忍態度。為防止此 類非法行為,本集團已實施嚴格的招聘控制 措施。如發現任何不符之處,例如年齡或身份 不匹配,本集團將立即終止與相關個人的僱 傭關係。此外,所有業務運作嚴格禁止強迫勞 動。

#### 僱員福利及薪酬

為保障員工權益,本集團已制定全面的員工 手冊及僱傭政策,涵蓋薪酬、晉升、工作時 數、假期及其他福利措施。我們定期審閱薪酬 及福利計劃,以確保有關計劃保持競爭力並 滿足我們員工的需求。

透過有效的員工評估及溝通,卓越的員工將 獲得認可、獎勵,並有機會獲得內部晉升及加 薪。此系統有助於確保表現優秀員工獲得適 當的重視及激勵。

#### **Open Communication and Fair Dismissal Practices**

The Group encourages close communication with employees to understand their needs and concerns. Regular internal meetings are held between directors and construction teams, ensuring that staff have opportunities to express their opinions. Feedback is provided during appraisals and when necessary. We also enforce a strict policy against illegal or unfair dismissal. All dismissals are reviewed and approved by responsible personnel, ensuring that they follow standard procedures and are in compliance with employment laws.

We believe the above policies and procedures help foster a positive, respectful, and inclusive work environment where employees are supported in their professional growth and their well-being is prioritized.

As of 31 December 2024, the Group has employed 43 (2023:45) full time employees under our construction and engineering services in Hong Kong, which is the Group's key business activities carried out in Hong Kong. The breakdowns of our workforce in the key operating units by gender, age group and employment types are as follows:

#### 公開溝涌及公平解僱慣例

本集團鼓勵與僱員保持緊密溝通,以了解彼等的需求和關注。董事與施工團隊之間定期舉行內部會議,確保員工有機會表達彼等的意見。於評估期間及必要時提供反饋。我們亦執行嚴格的政策,禁止非法或不公平解僱。所有解僱均由負責人員審核及批准,確保遵循標準程序並符合僱傭法律。

我們相信上述政策和程序有助營造一個積極、 尊重和包容的工作環境,讓員工在專業成長 上獲得支持,並將員工的福祉放在首位。

於二零二四年十二月三十一日,本集團有43名(二零二三年:45名)全職僱員,於香港提供建築及工程服務,這也是本集團在香港開展的主要業務活動。按性別、年齡組別及僱傭類型劃分的主要運營單位員工明細如下:

The Group has employment contracts with site workers, however, their work is not continuous and depends on the demand at construction sites. Work schedules are arranged with site workers as needed. Since site workers are daily-rated and remain on standby to supply the workforce, the breakdown of our workforce, as in the previous review year, does not include them. This also explains why entry-level staff make up a smaller portion of our workforce.

The turnover rate for the Review Year increased slightly from 28% to 36%, primarily due to normal employee attrition. We maintain only the necessary number of employees, without rehiring the same workers who leave. Additionally, since most site workers are paid on a daily basis and may leave and rejoin the Group multiple times throughout the year, they are excluded from the turnover rate calculation. This approach is consistent with the previous review year, as including site workers would not provide meaningful insights.

We maintain high standards of business ethics and require our employees to abide by the Group's code of conduct as stated in our staff handbook. During the Review Year, to the best of the Group's knowledge, we did not have any non-compliance issues in relation to preventing child and forced labour, compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity, diversity, anti-discrimination and other benefits and welfare.

#### Protecting staff health and safety

To provide a secure and safe working environment for its employees, the Group has implemented stringent internal health and safety policies, accredited under ISO 45001:2018. We require all employees to comply strictly with these safety policies and guidelines. The primary focus is on raising staff awareness of safety, especially in the potentially hazardous environment of construction sites, to prevent fatal or work-related injuries.

於回顧年度,流失率由28%略微增加至36%,主要由於正常的僱員自然流失所致。我們僅維持必要的僱員人數,不會重新聘用已離職的同一批工人。此外,由於大部分地盤工人按日收取薪酬,並可能於一年內多次離開及重投本集團,彼等不包括在流失率的計算中。此方法與上一回顧年度一致,因為計入地盤工人並無意義。

我們堅持最高的商業道德標準並要求僱員遵守本集團員工手冊所述的行為準則。於回顧年度內,就本集團所深知,我們並無有關防止童工及強迫勞工、薪酬及解僱、招聘及晉升、工作時數、假期、平等機會、多元化、反歧視以及其他待遇及福利的任何不合規問題。

#### 保護員工的健康及安全

為向其僱員提供安全和穩妥的工作環境,本集 團已實施嚴格的內部健康及安全政策,並獲 得ISO 45001:2018認證。我們要求所有僱員嚴 格遵守該等安全政策及指引。主要重點是提 高員工對安全的意識,特別是在施工工地這 種潛在危險的環境中,以防止致命傷害或工傷。

#### **Training and Awareness**

All workers are required to attend specific induction training and toolbox training before entering construction sites. Risk assessments are conducted to identify any hazardous areas, and these risks are communicated to workers before work begins. These training programs ensure that workers have a basic understanding of the environment and the risks present at the project sites. Additionally, refresher training is provided periodically to reinforce the importance of safety rules and to update workers on any new or evolving risks. Emergency drills are also carried out to prepare workers for potential hazards, such as fires or other emergency situations. These drills ensure that all staff members are familiar with safety protocols, evacuation routes, and the proper use of emergency equipment.

#### Personal Protective Equipment (PPE)

To ensure worker safety, the Group supplies all necessary PPE and safety gear, including helmets, boots, dust masks, reflective vests, and safety goggles. Workers are required to wear the appropriate safety gear at all times while on construction sites. Regular communication of work safety notices and procedures helps reinforce safety awareness. Our safety officers and supervisors ensure all safety measures are adhered to, conducting routine site inspections to identify and address any unsafe conditions. Additionally, workers are trained to report any issues with their PPE, ensuring that it remains functional and safe to use at all times.

#### Safety Reporting and Continuous Improvement

Our group's health and safety policies are regularly reviewed to ensure they align with the latest operational and statutory compliance requirements.

In our ongoing efforts to mitigate work injury risks, an annual safety and environmental report is prepared by our Safety and Environmental Manager. This report includes statistics on workplace accidents, helping us track safety performance and identify areas for improvement. During the Review Year, there were no lost man-days due to work injury (2023: nil).

Additionally, we are implementing a proactive reporting system to encourage workers to report any potential hazards before they result in accidents. This helps us identify and address safety concerns at an early stage, further reducing the risk of work-related injuries.

#### 培訓與意識

所有工人必須在進入施工工地前參加特定的 入職培訓及工地座談會培訓。我們會進行風 險評估,以識別任何危險區域,並在工作開始 之前向工人通報這些風險。這些培訓計劃確 保工人對項目工地的環境及存在的風險有基 本的了解。此外,我們亦定期提供進修培訓, 以加強安全規則的重要性,並向工人更新任 何新的或不斷演變的風險。我們進行緊急演 習,讓員工對潛在的危險做好準備,例如火災 或其他緊急情況。這些演習確保所有員工熟 悉安全程序、疏散路線及正確使用緊急設備。

#### 個人防護裝備

為確保工人安全,本集團提供所有必要的個人防護裝備及安全裝置,包括安全帽、安全靴、防塵面具、反光衣及護目鏡。工人在施工工地時必須時刻佩戴適當的安全裝備。我們定至通知及程序,有助加強確全,有助加強確保,以強全措施得到遵循,定期進行地盤視察,以讓別和解決任何不安全的情況。此外,工人養期,要求彼等報告任何有關個人防護裝備的問題,以確保裝備始終保持功能正常及安全可用。

#### 安全報告及持續改善

本集團定期檢討健康及安全政策,以確保符 合最新的營運及法定合規要求。

在我們持續努力降低工傷風險的過程中,我們的安全及環境經理編製年度安全及環境報告。該報告包括有關工作場所事故的統計數據,幫助我們追蹤安全表現並識別改善的範疇。於回顧年度,並無因工傷而損失的工作日(二零二三年:無)。

此外,我們正實施主動通報系統,以鼓勵工人報告任何潛在的危險,以防止事故發生。此舉有助我們及早識別和解決安全問題,進一步降低與工傷風險。

#### **Managing Risks at Heights**

As our work frequently involves tasks performed at heights, the Group has implemented both short-term and long-term measures outlined in the safety enhancement plan to mitigate the risk of work-related injuries from falls. The following measures have been put in place:

- Daily pre-work hazard identification activities and safety briefings are conducted for all projects, including both public and private works.
   This ensures that all workers are constantly reminded of site safety, including safe working practices at height.
- A top and senior management safety inspection program has been established, which includes surprise site checks across both private and public works sites. Findings from these inspections are discussed during internal monthly meetings.
- Workers who perform tasks at height are required to use double lanyard safety harnesses, ensuring continuous anchorage of the fallarresting system throughout their work.
- A "Hold-point" control system has been developed for pre-work site safety assessments and inspections. Tailor-made control measures for work-at-height activities are designed based on specific site conditions, with proper documentation in place to ensure safety.

#### **Managing Risks in Extreme Weather Conditions**

Working outdoors in high temperatures, particularly during the summer months, poses significant risks to workers. The Group has implemented measures to adequately prepare for and protect our workers from heat-related risks. These measures include:

- Providing regular rest breaks and ample supplies of fluids for workers
- Offering training on managing heat stress, adapting to hot environments, and implementing control techniques.
- Establishing a heat-stress warning system at worksites.
- Conducting specific risk assessments by qualified personnel before work commences.

During the past three years, number and rate of work-related fatalities were as follow:

#### 高空作業風險管理

由於我們的工程經常涉及高空作業,本集團已實施安全增強計劃中規定的短期及長期措施,以減輕因墜落而導致的工傷風險。以下措施已經實施:

- 每天進行工作前的危險識別活動和安全 簡報,涵蓋所有項目,包括公共及私人 工程。確保所有工人時刻被提醒地盤安 全,包括高空作業的安全工作常規。
- 已建立最高及高級管理層安全檢查計劃,包括對私人工程及公共工程地盤進行突擊檢查。在每月的內部會議上討論這些檢查的結果。
- 在高空作業的工人必須使用雙懸掛繩, 以確保在工作期間持續固定防墜系統。
- 開發「停工待檢點」控制系統,用於工作 前的地盤安全評估和檢查。根據特定地 盤條件及適當的文件,為高空作業活動 設計量身定制的控制措施,以確保安全。

#### 在極端天氣條件下管理風險

在高溫下戶外工作,特別是在夏季,對工人構成重大風險。本集團已採取措施以充分準備並保護我們的工人免受與高溫相關的風險。 這些措施包括:

- 為工人提供定期的休息時間和充足的水分補充。
- · 提供有關管理高溫壓力、適應炎熱環境 及實施控制技術的培訓。
- 在工作場所建立高溫壓力警告系統。
- 由合資格人員在工作開始前進行特定風險評估。

We believe that open communication with frontline workers is key to improving site safety management. Workers are encouraged to voice concerns and suggestions, particularly regarding safety and health. We require staff to report any potential occupational health and safety issues to the Group.

The Group is committed to providing a safe and secure working environment by continually improving safety measures. This includes offering proper training, supplying necessary protective equipment, and proactively managing risks. While the construction industry presents challenges, such as hazardous environments and extreme weather, we remain focused on reducing injuries and maintaining a workplace where safety is a top priority.

During the Review Year, we have no non-compliance relating to providing a safe working environment and protecting employees from occupational hazards.

#### **Training and Development**

The Group places a strong emphasis on enhancing employees' professional skills and fostering their development from the outset. All new employees receive a staff handbook and participate in orientation sessions to familiarize themselves with their job duties and the Group's expectations, ensuring they are well-prepared to contribute effectively. Beyond onboarding, the Group actively supports continuous professional development by encouraging employees with professional qualifications to enrol in external training relevant to their roles. Additionally, internal training courses are organized to keep employees up to date with market developments, and discretionary training sponsorships are offered for courses related to their job duties and career growth.

For safety-related site training, the Group adheres to the requirements of the Construction Site Safety Manual of the Development Bureau of Hong Kong. Each project prepares training plans, which include mandatory one-hour induction sessions and 15-minute toolbox talks. In addition to safety training, the induction sessions also cover environmental topics, such as the Group's environmental policy, organizational structure, control measures (e.g., air quality, noise impact), and internal safety rules and regulations.

The total number of hours allocated for the aforementioned training (induction and toolbox talks) for site workers during the Review Year was 565 (2023: 235 hours). Since attendance at these training sessions is mandatory for all site workers, the breakdown of workforce training and average training hours completed per employee specifically applies to employees other than site workers.

我們相信,與前線工人之間的開放溝通是改善 地盤安全管理的關鍵。我們鼓勵員工提出關 於安全和健康的擔憂和建議。我們要求員工 向本集團報告任何潛在的職業健康及安全問題。

本集團致力通過不斷改善安全措施,提供安全可靠的工作環境。措施包括提供適當的培訓、供應必要的防護裝備,以及主動管理風險。儘管建造業面臨危險環境和極端天氣等挑戰,我們仍然專注於減少傷害,並維持以安全為首要任務的工作場所。

於回顧年度內·我們並無發生有關提供安全 工作環境及保護員工免受職業危害的任何不 合規情況。

#### 培訓及發展

本集團非常重視提升員工的專業技能,並從一開始就促進彼等的發展。所有新入職員工 均會收到員工手冊,並參加入職培訓,以便熟 悉其工作職責及本集團的期望,確保彼等能 夠做好充分準備,作出有效貢獻。除了入職培 訓外,本集團積極支持持續專業發展,鼓勵具 專業資格的僱員報名參加與其職位相關的外 部培訓。此外,我們會定期舉辦內部培訓 程,以使員工掌握市場發展的最新動態,並針 對與員工工作職責及職涯發展相關的課程, 提供酌情培訓贊助。

對於安全相關的地盤培訓,本集團遵守香港發展局的建築地盤安全手冊的規定。每個項目均會準備培訓計劃,其中包括強制性的一小時入職培訓和十五分鐘的工地座談會。除安全培訓外,入職培訓課程亦涵蓋環境議題,例如本集團的環境政策、組織結構、控制措施(例如空氣質量、噪音影響)以及內部安全規則和法規。

於回顧年度,上述培訓(入職培訓及工地座談會)的總時數為565小時(二零二三年:235小時)。由於所有地盤工人均必須參加該等培訓課程,因此有關員工接受培訓的明細及每名僱員平均完成培訓時數僅適用於地盤工人以外的僱員。

#### **II.2** Operational Practices

#### **Supply Chain Management**

The Group views suppliers and subcontractors as essential elements in our daily operations, which is why we only work with approved and assessed suppliers and subcontractors. We have established policies and procedures to ensure proper selection and monitoring of these partners. For the Review Year, the Group has 143 (2023: 123) approved suppliers, including both subcontractors and material suppliers, all of whom are located in Hong Kong to reduce transportation costs.

When sourcing new material suppliers or subcontractors, the Group follows a fair and impartial selection process. All suppliers and subcontractors are expected to adhere to the same standards. We conduct thorough background research, considering factors such as pricing, location, delivery method, product and service quality, service support, and the supplier's track record regarding environmental and social responsibility. If any instances of non-compliance or negative impacts on environmental or social aspects are noted, we take corrective action and implement measures to prevent the issue from recurring.

In cases where suppliers or subcontractors offer comparable packages, we prioritize those with green products or relevant environmental and social accreditations, in line with our selection criteria.

Suppliers and subcontractors are subject to continuous monitoring by the Group. Material suppliers must provide product quality and specification certificates to ensure their materials meet both our and our customers' requirements. Other factors, such as delivery time, post-sales service, and pricing, are also evaluated during regular supplier reviews.

Subcontractor performance is monitored daily by our project team and site representatives, who conduct site visits to assess work quality and ensure compliance with environmental and social standards, including the prevention of forced or child labor. In addition to site visits, the Group performs weekly environmental inspections, reviews attendance at environmental meetings and training, and examines records of environmental incidents. If any non-compliance with relevant requirements is identified, subcontractors are required to immediately rectify unsafe practices or conditions. Additionally, we require subcontractors to report any instances of non-compliance as soon as they become aware of them.

Annual evaluations are performed to assess both suppliers and subcontractors. Those who fail to meet the Group's standards for performance and quality may be replaced. To ensure compliance, we have implemented a penalty system for environmental violations committed by subcontractors. These breaches are categorized based on their severity, with corresponding penalties. It is essential for our suppliers and subcontractors to meet our standards, as severe breaches may result in the termination of business relationships.

#### II.2 營運慣例

#### 供應鏈管理

本集團視供應商及分包商為我們日常營運中的重要元素,因此我們僅與認可及經評估的供應商及分包商合作。我們已制定政策及程序,以確保妥善選擇及監督該等合作夥伴。於回顧年度,本集團有143間(二零二三年:123間)認可供應商,包括分包商及材料供應商,彼等均价於香港,以減少運輸成本。

在物色新材料供應商或分包商時,本集團遵循公平公正的甄選流程。所有供應商及分包商預期需遵守相同的標準。我們進行徹底的背景調查,考慮因素包括定價、地點、交付方式、產品及服務質量、服務支援,以及供應商在環境和社會責任方面的往績記錄。倘發現任何不合規或對環境或社會方面造成負面影響的情況,我們將採取糾正行動並實施措施以防止問題再次發生。

在供應商或分包商提供相若方案的情況下, 我們優先考慮具有綠色產品或相關環境及社會認證的供應商或分包商,以符合我們的甄 選標準。

本集團對供應商及分包商進行持續監察。材料 供應商必須提供產品質量和規格證書,以確 保其材料符合我們及客戶的要求。其他因素(例 如交付時間、售後服務及定價)亦在定期供應 商審查中進行評估。

我們的項目團隊及地盤代表每天監察分包商的表現,並進行現場視察以評估工作質量,確保符合環境及社會標準,包括防止強制勞工或童工。除現場視察外,本集團亦進行每週環境檢查,審查環境會議及培訓的出席情況,並檢查環境事故的紀錄。倘發現任何不符合相關要求的情況,分包商須即時糾正不安全行為或情況。此外,我們要求分包商在發現任何不合規情況後盡快向我們報告。

我們會進行年度評估,以評估供應商及分包商。倘供應商及分包商未能達到本集團表現及質量標準,可能會被更換。為確保合規,我們已對分包商所犯的環境違規實施處罰制度。該等違規行為根據其嚴重程度進行分類,並有相應的罰則。我們的供應商及分包商必須符合我們的標準,因為嚴重違規可能導致業務關係終止。

#### Service pledge to our customers

We believe that performing quality work in a safe environment is fundamental to maintaining our corporate high-quality standards and earning the trust of our customers. To ensure this, we have established comprehensive work procedures accredited by ISO 9001:2015, and our safety policies and procedures are accredited by ISO 45001:2018.

In the course of performing construction and engineering work, only materials that comply with customer specifications are used. Each project is assigned a dedicated team, including a project manager and site representative, who are responsible for overseeing the groundwork, conducting reviews, and monitoring progress to ensure quality at every stage in line with customer requirements. The site representative plays a crucial role in monitoring the engineering work and maintaining immediate communication with customers and subcontractors. They address any project-related issues, such as quality, safety, environmental concerns, or risks, and request team members to take corrective actions as needed.

Our dedicated project teams conduct regular site visits to ensure that work progress, environmental standards, and safety conditions for workers and subcontractors meet the required criteria. Additionally, the quality of our work is consistently certified by customer representatives.

To further ensure the effectiveness of our health and safety systems, the Group has established a corporate safety management committee to oversee safety standards. Monthly safety meetings are held to review accident statistics, reporting procedures, updates on relevant regulations, and safety training data. The Group adheres to the highest health and safety standards, conducting regular audits by external consultants to verify compliance. We also carry out regulatory safety audits as required by law. Our construction teams consistently follow health and safety guidelines outlined in service contracts and certifications provided by professional engineers engaged by our clients, reinforcing the Group's commitment to maintaining the highest quality and safety standards.

Given the nature of our construction and engineering business, recall procedures for quality, safety, and health are not applicable. During the Review Year, there were no complaints or claims from customers regarding the quality of work performed by the Group or its subcontractors, which demonstrates the effectiveness of our quality control measures.

#### 客戶服務承諾

我們相信,在安全的環境中進行高質量的工作是維持我們企業高質量標準和贏得客戶信任的基礎。為確保這一點,我們已建立經ISO 9001:2015 認證的全面工作程序,我們的安全政策和程序亦已獲ISO 45001:2018 認證。

在進行建築及工程工作時,僅使用符合客戶規格的材料。每個項目均會指派一支專責團隊,包括項目經理及地盤代表,負責監督準備工作、進行審查及監察進度,以確保每個階段的質量符合客戶要求。工地代表在監督工程工作及與客戶和分包商保持即時溝通方面發揮重要作用。彼等處理任何與項目相關的問題,例如質量、安全、環境關注或風險,並要求團隊成員在需要時採取糾正措施。

專責項目團隊定期進行現場考察,以確保工作進度、環境標準及工人和分包商的安全條件符合所需準則。此外,我們的工作質量一貫由客戶代表認證。

為進一步確保我們健康及安全系統的效能,本集團已成立公司安全管理委員會以監督安全標準。我們每月召開安全會議,以審閱事故統計數據、報告程序、相關法規更新及安全標準的謝數據。本集團堅持最高的健康及安全標準的建等團隊一直遵循服務合約中列明的健康及安全指引,以及客戶委聘的專業工程量所及安全指引,以及客戶委聘的專業工程量及安全標準的承諾。

由於我們建築及工程業務的業務性質,質量、 安全及健康的召回程序不適用。於回顧年度 內,客戶並無就本集團或其分包商所執行工 作的質量提出投訴或索賠,顯示我們質量監 控措施的成效。

#### Advertising and labelling

As a construction company, we do not engage in traditional advertising methods. Instead, we showcase our capabilities through the quality and performance of our work. Our reputation is built on the successful completion of projects, which serve as a testament to our expertise and reliability in the industry. Our website provides factual information about our company, including corporate details, organizational structure, and the services we offer. We focus on delivering transparent, accurate information to potential clients, ensuring they can make informed decisions based on our proven track record and commitment to excellence. In line with this approach, the Group believes that product labelling is not applicable to our business and, therefore, does not require the disclosure of related information.

# Protection of data privacy and intellectual property rights

The Group is committed to maintaining the confidentiality of all personal and sensitive business data. To ensure secure handling, such information is stored in designated areas within our office, with access strictly limited to authorized personnel. Clear guidelines have been established to reinforce confidentiality, ensuring that only approved staff can access sensitive data. Additionally, to prevent unauthorized access, confidential information is used exclusively within office premises, and all documents containing sensitive data are securely shredded before disposal or recycling.

Beyond data protection, the Group also upholds intellectual property rights and ensures compliance with all relevant regulations. To prevent infringement and maintain legal integrity, only licensed software is used in our business operations. Employees are strictly prohibited from installing pirated or personal software on company computers, reinforcing our commitment to ethical and lawful business practices.

To the best of the Directors' knowledge, the Group is not aware of any cases of non-compliance of the applicable laws and regulation on customer health and safety, advertising, labelling, and privacy matters relating to our services provided in the Review Year.

#### **Anti-Corruption**

The Group strictly prohibits the acceptance of kickbacks, commissions, or any other benefits, as well as any form of bribery, extortion, fraud, or money laundering. Clear policies and procedures have been established to reinforce this commitment, ensuring employees understand and uphold professional and ethical standards. Additionally, our internal manuals outline a gift policy that specifies the proper processes and procedures for handling and accepting gifts and advantages. To further strengthen our anti-corruption efforts, senior management participated in anti-corruption training during the Review Year, reinforcing the importance of ethical practices and continuous awareness.

#### 廣告及標籤

作為一家建築公司,我們不採用傳統的廣告 方法。相反,我們透過工作的質量和表現展示 我們的能力。我們的聲譽建立在成功完成的 項目上,這些項目證明我們在行業中的專業 知識和可靠性。我們的網站提供有關本公司 的事實資料,包括企業詳情、組織架構及我們 提供的服務。我們專注於向潛在客戶提供透 明、準確的資料,確保彼等能夠根據我們的 靠往績記錄和卓越承諾作出知情決定。根據 此方法,本集團認為產品標籤不適用於我們 的業務,因此毋需披露相關資料。

#### 保護資料私隱及知識產權

本集團致力維持所有個人及敏感業務數據的 保密性。為確保安全處理,該等資料存儲於我 們辦公室內的指定區域,並嚴格限制授權人 員的查閱權限。我們已制定明確指引以加強 保密性,確保只有獲批准的員工才能查閱敏 感數據。此外,為防止未經授權查閱,機密資 料僅限於辦公室內使用,而所有包含敏感數 據的文件在處理或回收前會被撕碎。

除數據保護外,本集團亦維護知識產權,並確保遵守所有相關法規。為防止侵權並維護法律完整性,我們在業務營運中僅使用獲許可軟件。我們嚴禁員工在公司電腦上安裝盜版或私人軟件,以加強我們對道德和合法商業行為的承諾。

據董事所深知,於回顧年度內,本集團並不知 悉任何有關客戶健康及安全、廣告、標籤及與 所提供的服務有關的私隱事宜而違反適用法 律法規的案件。

#### 反貪污

本集團嚴格禁止收受回扣、佣金或任何其他利益,以及任何形式的賄賂、勒索、欺詐或洗錢活動。我們已建立明確的政策和程序以加強這一承諾,確保僱員理解並維持專業和道德標準。此外,我們的內部手冊載述餽贈政策,列明處理及收受禮物及利益的必要程序及手續。為進一步加強我們的反貪污工作,高級管理層於回顧年度參加反貪污培訓,強調道德操守的重要性及持續提高意識。

To the best of our knowledge, the Group did not experience any instances of non-compliance related to bribery, extortion, fraud, or money laundering during the Review Year. Furthermore, no legal cases concerning corrupt practices were brought against the Group or its employees.

To promote integrity and transparency, the Group has established whistleblower channels that enable employees, business partners, and other stakeholders to report suspected misconduct, malpractice, or corruption without fear of retaliation. These channels are designed to provide a safe and accessible platform for individuals to raise concerns, ensuring that ethical standards are upheld across all levels of the organization. Reports submitted will be thoroughly investigated by a dedicated team with strict confidentiality, and appropriate actions will be taken based on the findings. Additionally, we continuously review and enhance our reporting mechanisms to strengthen our corporate governance framework and reinforce a culture of accountability and ethical business conduct.

#### **II.3** Community Involvement

The Group is committed to giving back to society by supporting future talent and fostering a culture of community engagement among employees. This year, we reinforced our dedication to the geotechnical industry through a recurring monetary donation to the Hong Kong Institution of Engineers (HKIE) Geotechnical Division, supporting its efforts to advance the field and drive future development. While we encourage our employees to participate in volunteer work and charitable initiatives to assist those in need, our company remains focused on geotechnical development in Hong Kong. By investing in education and industry growth, we aim to nurture talent and contribute to the sector's long-term progress.

據我們所深知,於回顧年度內,本集團並無發 生任何與賄賂、勒索、欺詐或洗錢相關的不合 規情況。此外,概無對本集團或我們的僱員提 出的貪污訴訟案件。

為促進誠信和透明度,本集團已設立舉報渠道,以便員工、業務夥伴及其他持份者能夠在無懼報復的情況下舉報涉嫌不當行為、不法行為或貪污。這些渠道旨在提供安全及便利平台,讓個別人士能夠提出關注,確保在組織的各個層面維持道德標準。所提交報告將由專責團隊進行徹底調查,並嚴格保密,其後根據調查結果採取適當行動。此外,我們不斷檢討及加強報告機制,以鞏固我們的企業管治框架並加強問責文化及道德商業行為。

# Directors' Report 董事會報告

The Board is pleased to present the annual report together with the audited consolidated financial statements of the Group for the year ended 31 December 2024.

#### PRINCIPAL PLACE OF BUSINESS

The principal place of business of the Company is located at Unit 706-708, 7th Floor, Tower II, Metroplaza, 223 Hing Fong Road, Kwai Chung, New Territories, Hong Kong.

#### **PRINCIPAL ACTIVITIES**

The Company is an investment holding company. The principal activities of the subsidiaries are set out in note 1 to the consolidated financial statements.

#### **RESULTS**

The results of the Group for the year ended 31 December 2024 are set out in the section headed "CONSOLIDATED STATEMENT OF PROFIT OR LOSS AND OTHER COMPREHENSIVE INCOME" on page 93 in this annual report.

#### **SUMMARY OF FINANCIAL INFORMATION**

A summary of the results and assets and liabilities of the Group for the last five financial years as extracted from the audited financial statements and restated/reclassified as appropriate, is set out on pages 171 to 172 in this annual report. This summary does not form part of the audited financial statements.

#### **BUSINESS REVIEW**

The Group expanded into the sales of luxury products in the fourth quarter of 2023. The business review of the Group for the year ended 31 December 2024 and discussion on the Group's future business development are set out in the section headed "CHAIRMAN'S STATEMENT" and "MANAGEMENT DISCUSSION AND ANALYSIS" on page 4 and pages 5 to 13 respectively in this annual report. #### **ENVIRONMENTAL POLICIES AND PERFORMANCE**

In conducting its business, the Group endeavours to protect the environment in which it operates and the Board is committed to sustainable development as its responsibility. The Group has implemented an environmental management plan and established quality and environmental management systems and been certified under ISO 9001:2015 and ISO 14001:2015 for its construction and engineering services. During the year, there was no non-compliance in relation to environmental laws and regulations in Hong Kong including air pollution, noise control and waste disposal. Green office practices are also encouraged in the operation of the Group's businesses, such as recycle used paper for printing, re-use old envelopes for internal communication, prefer electronic to printed communication and reduce energy consumption by setting the temperature at an eco-friendly level of 25° C and by switching off idle lighting. The Group also targets to reduce water usage, greenhouse gas and non-hazardous wastes in the long term. A detailed discussion on the Group's environmental policies and performance and the stakeholder relationships are contained in the "Environmental, Social and Governance Report" on page 35 to 69 of this annual report.

#### SIGNIFICANT EVENTS AFTER REPORTING PERIOD

The Group did not have any significant event subsequent to the year ended 31 December 2024 and up to the date of this annual report.

#### **KEY RISKS AND UNCERTAINTIES**

The following are some principal risks and uncertainties facing the Group, which may materially and adversely affect its businesses, financial condition or results of operations in (i) construction and engineering services; (ii) property-related services; and (iii) sales of luxury products.

#### (1) Uncertain external factors

The Group's operation of the construction and engineering services, property-related services and sales of luxury products are mainly located in Hong Kong. Uncertain external factors including the downturn in the economy of Hong Kong and public health issues such as the COVID-19 pandemic, may materially and adversely affect the Group's businesses in construction and engineering services and property-related services, results of operations and prospects. The Group will continue to closely monitor the market situation and to consider appropriate strategies to promptly respond to the risks to minimise potential adverse effects on the Group's business performance and financial condition.

# (2) Construction and engineering services — reliance on the public sector contracts granted by the Government departments and statutory bodies

The Government departments and statutory bodies have been and are expected to continue to be the Group's largest customers in construction and engineering services. During the year ended 31 December 2024, revenue attributed to the public sector projects represented approximately 62.0% (2023: approximately 87.5%) of the Group's total revenue. If there is any reduction or significant delay in the spending of the Government departments and statutory bodies in the construction and civil engineering industry, the Group's business in construction and engineering services, results of operations and financial positions may be materially and adversely affected. In order to cope with the risk of relying on the public sector contracts in the construction and engineering market, the Group will continuously explore or seek other business opportunities that are beneficial to the long-term development of the Group so as to diversify the risks.

#### 附屬公司

## 主要風險及不確定因素

以下為本集團面臨的若干主要風險及不確定因素,其可能對本集團在(i)建築及工程服務;(ii)物業相關服務;及(iii)奢侈品銷售方面的業務、財務狀況或營運業績造成重大不利影響。

#### (1) 外部不確定性因素

本集團的建築及工程服務、物業相關服務以及奢侈品銷售業務主要位於香港。香港經濟低迷及公眾健康問題(如 COVID-19疫情)等外部不確定性因素,或會對本集團的建築及工程服務以及物業相關服務的業務、經營業績及前景造成重大不利影響。本集團將繼續密切監察市場形勢及考慮適當策略迅速應對風險,以減少對本集團業務表現及財務狀況的潛在不利影響。

### (2) 建築及工程服務 — 依賴政府部門及法 定機構授予的公營部門合約

政府部門及法定機構已成為及預期仍為本集團建築及工程服務的最大客戶。於截至二零二四年十二月三十一日止年度,公營部門項目的收益佔本集團總收益約62.0%(二零二三年:約87.5%)。倘政府部門及法定機構於建築及土木工程行業的支出減少或出現嚴重推延,則本集團建築及工程服務的業務、經營業績及財務狀況或會受到重大不利影響。為應對在建築及工程市場中依賴公營部門合約的風險,本集團會繼續探索或尋求其他對本集團長遠發展有利的商機以分散該等風險。

#### (3) Competitive tendering process and making of estimates

The construction and engineering business of the Group operates on a non-recurring and project-by-project basis. We have no long-term commitments with our customers but rely on successful tenders that determine the award of construction contracts. The number of contracts awarded to the Group, therefore, may vary from time to time. Upon completion of its contracts on hand, the Group's financial performance may adversely be affected if the Group is unable to secure new tenders or obtain new contract with comparable contract sums or at all. As such, to cope with the keen market competition, the Group has adopted a competitive pricing strategy for tendering in order to maintain the competitiveness of tenders which may further narrow the profit margin. The Group will assess and adjust its business strategy from time to time to adapt to the market environment in order to maintain the Group's competitiveness in the construction and engineering market.

Further, in the tendering process, the Group determines a tender price by estimating the construction costs under the contract duration as specified in the tender invitation documents. However, the actual implementation of projects may not accord with our estimation at the time of tender due to cost overruns and/ or subject to other related construction risks. If our estimates of the overall risks, revenue or costs prove inaccurate, the Group will experience lower profitability or even make losses on contracts, which could materially and adversely affect the Group's business, financial condition, results of operations and prospects.

#### (4) Highly regulated industry — reliance on registrations, licences and/or certifications

The construction and engineering industry is a highly regulated industry and our business is subject to various government regulations. In accordance with the regulations and contract requirements, the Group is required to obtain or maintain certain registrations, licences and/or certification ("Licences") to operate its business. All such Licences are granted/renewed and maintained upon the satisfactory compliance by the Group with, among others, the applicable criteria set by the relevant government departments or organisations including Development Bureau and Building Authority. Such criteria may include the maintenance of quality standards, financial capability, expertise, management, environmental and safety. Circumstances which may lead to taking of regulatory actions against a contractor and/or subcontractor include but not limited to poor site safety record, violation of laws and misconduct etc. These Licences may only be valid for a limited period of time and are subject to periodic reviews and renewal by relevant government departments and organisations. In addition, the standards of compliance required in relation thereto may from time to time be subject to changes without substantial advance notice. Failure to renew or maintain these Licenses and regulatory actions such as suspension, downgrading or demotion of relevant construction and engineering businesses operated by the Group, may have an adverse effect on our business, results of operation, financial condition and prospects unless we have similar Licences within the Group.

#### (3) 激烈的競標過程及作出估計

本集團乃根據非經常性及按個別項目基準經營建築及工程業務。我們與客戶並無長期承擔,惟依賴成功中標與否而決定是否獲授建築合約。因此,為無團獲授予的合約數量可能時有不同。於手頭合約金額的新合約或兩者都不可獲得,則本集團內的金額的新合約或兩者都不可獲得,則本集團內別數分數。因此,為應對激烈的方數,本集團已就投標採取具有競爭力的定價致略以維持投標時的競爭力,但此舉或會進一步導致毛利率收窄。為維持本集團於建築及工程市場的競爭力,本集團將不時評估及調整其業務策略以適應市場環境。

此外,於投標過程中,本集團根據邀標文件所訂明的合約期限,透過估計建築成本釐定投標價。然而,由於成本超支及/或面臨其他相關建築風險,項目實際施工未必與我們於招標時的估計相符。倘我們對整體風險、收益或成本的估計不準確,本集團將面臨盈利能力下降,甚至會因合約而蒙受損失,進而可能對本集團的業務、財務狀況、經營業績及前景造成重大不利影響。

# (4) 受高度監管的行業 — 依賴註冊、牌照及/或證書

建築及工程行業為受高度監管的行業,而我們的業 務須遵守多項政府規例。根據法規及合約規定,本 集團須取得或維持若干註冊、牌照及/或證書(「牌 照」) 以經營其業務。所有相關牌照須待有關政府部 門或機構(包括發展局及屋宇署)信納本集團遵守(其 中包括)彼等設立的適用準則後,方可授出/更新及 保留。有關準則可能包括質量標準、財務能力、專業 知識、管理、環境及安全的維護。可能導致對一名承 包商及/或分包商採取監管措施的情況包括但不限 於地盤安全記錄欠佳、觸犯法例及不當行為等。該 等牌照可能僅於限定期內有效,且須相關政府部門 及機構定期檢視及更新。此外,有關彼等規定合規 的準則或會不時變動而毋須提前通知。除非我們於 本集團範圍內持有類似的牌照,否則未能更新或維 持牌照及對本集團經營的相關建築及工程業務進行 暫停、降級或降格等監管行動或會對我們的業務、 經營業績、財務狀況及前景產生不利影響。

#### (5) Property-related services — management's estimates

The Group's property management consultancy services are charged on a fixed fee basis, it is important to accurately estimate the cost in preparing fee quotation/ proposal to customers and to make sure the fixed fee covers all the costs to be incurred for the provision of such services. If the Group fails to estimate the potential increase in costs accurately, it may experience lower profitability or even make losses, which could materially and adversely affect the Group's business, financial condition, results of operations and prospects.

#### (6) Sales of luxury products — macroeconomic environment

Macroeconomic changes may affect consumers' behavior. Luxury products are considered as discretionary items for customers. Slower consumer spending momentum may reduce the demand for our products, leading to lower revenue and margins. It is therefore important that the Group is aware of any such changes in the economic environment and adjusts its purchase strategy and business plan under different market conditions.

#### **SHARE CAPITAL**

The Company's total issued share capital as at 31 December 2024 was HK\$16,800,000 divided into 1,680,000,000 Shares with par value of HK\$0.01 per Share.

Detailed movements of the share capital of the Company during the year ended 31 December 2024 are set out in note 24 to the consolidated financial statements.

#### **RESERVES**

Detailed movements of the Group's reserves during the year ended 31 December 2024 are set out in the section headed "CONSOLIDATED STATEMENT OF CHANGES IN EQUITY" on page 95 in this annual report.

As at 31 December 2024, the Company has reserves amounted to approximately HK\$9.7 million available for distribution to shareholders (31 December 2023: approximately HK\$87.3 million).

#### **COMPLIANCE WITH LAWS AND REGULATIONS**

The Group was not aware of any non-compliance with laws and regulations that would have a significant impact on the Group for the year ended 31 December 2024.

#### (5) 物業相關服務 — 管理層的估計

本集團的物業管理顧問服務按固定基準收費,故準確估計籌備將交付客戶的費用報價/方案及確保固定費用涵蓋提供有關服務所產生的所有成本極為重要。倘本集團未能準確估計成本的潛在增長,其可能面臨盈利能力下降甚至遭受虧損,從而或會對本集團的業務、財務狀況、經營業績及前景造成重大不利影響。

#### (6) 奢侈品銷售 — 宏觀經濟環境

宏觀經濟變化可能會影響消費者的行為。奢侈品被視為客戶的非必需消費品。消費者消費動力放緩可能會減少對我們產品的需求,導致收益及利潤率下降。因此,本集團必須了解經濟環境的任何有關變化,並在不同市況下調整其採購策略及業務計劃。

On 27 December 2019, Nova Management Services Limited ("**Nova**") (as the consultant), an indirect wholly-owned subsidiary of the Company, entered into a property leasing and management consultancy agreement (the "**Property Management Consultancy Agreement**") with Cheer Capital Limited ("**Cheer Capital**") (as the property owner), in relation to the provision of property management consultancy services for a commercial property in Hong Kong owned by Cheer Capital (the "**Property**") for a term of three years from 1 January 2020 to 31 December 2022.

On the same date, Nova (as the agent) also entered into a property leasing agency agreement (the "Leasing Agency Agreement") with Cheer Capital (as the property owner) in relation to the provision of property leasing agency services in relation to the Property for prospective tenants referred by Cheer Capital or existing tenants of the Property (collectively the "Agency Tenant(s)"). Such services include handling enquiries and introductions, negotiation on leasing terms and conditions, site visit(s) arrangement and preparation and execution of formal agreement(s) with the Agency Tenants, for a term of three years from 1 January 2020 to 31 December 2022.

On 28 December 2022, the Property Management Consultancy Agreement and the Leasing Agency Agreement were renewed for a term of three years from 1 January 2023 to 31 December 2025 and to set the corresponding annual caps. The other terms of the Property Management Consultancy Agreement and the Leasing Agency Agreement remain unchanged.

Through the engagements of the Property Management Consultancy Agreement and the Leasing Agency Agreement which are of a recurring nature, it enables a more diversified revenue base and stable cash inflow for the Group.

Cheer Capital is a company indirectly and wholly-owned by Mr. Chen Zhi, the chairman of the Board and an executive Director and the controlling shareholder of the Company. As such, Cheer Capital is a connected person of the Company and the transactions contemplated under the Property Management Consultancy Agreement and Leasing Agency Agreement constitute continuing connected transactions (collectively, the "Continuing Connected Transactions"). Detailed terms of the Property Management Consultancy Agreement and Leasing Agency Agreement were set out in the announcements of the Company dated 27 December 2019 and 28 December 2022.

於同日,新星(作為代理)亦與千利(作為物業擁有人)簽訂物業租賃代理協議(「租賃代理協議」),內容有關就該物業向千利指定的預期租戶或該物業現有的租戶(統稱「代理租戶」)提供物業租賃代理服務。有關服務包括處理查詢及介紹、洽談租約條款及條件、安排場地考察及準備和執行與代理租戶的正式租約的租賃代理事務,協議由二零二零年一月一日起至二零二二年十二月三十一日止,為期三年。

於二零二二年十二月二十八日,物業管理顧問協議及租賃 代理協議獲重續,由二零二三年一月一日至二零二五年 十二月三十一日,為期三年,以及設定相關年度上限。物 業管理顧問協議及租賃代理協議之其他條款保持不變。

通過訂立經常性質的物業管理顧問協議及租賃代理協議, 可使本集團的收益基礎更加多元,並確保為本集團穩定的 現金流入。

千利為本公司董事會主席、執行董事及控股股東陳志先生間接全資擁有的公司。因此,千利為本公司的關連人士,物業管理顧問協議及租賃代理協議項下擬進行的交易構成持續關連交易(統稱,「持續關連交易」)。有關物業管理顧問協議及租賃代理協議的詳細條款載於本公司日期為二零一九年十二月二十七日及二零二二年十二月二十八日之公告。

It was expected that the aggregated annual caps pursuant to the Property Management Consultancy Agreement and Leasing Agency Agreement shall be HK\$6,497,000, HK\$5,380,000 and HK\$5,517,000 for each of the three years ending 31 December 2023, 2024 and 2025 respectively. The income received for services provided by Nova pursuant to the Property Management Consultancy Agreement and Leasing Agency Agreement aggregately amounted to approximately HK\$5,045,000 which is within the aggregated annual cap of HK\$5,380,000 for the year ended 31 December 2024. Details of the transactions are set out in note 28 to the consolidated financial statements.

The independent non-executive Directors of the Company have reviewed and confirmed that the above Continuing Connected Transactions for the year ended 31 December 2024 have been entered into (i) in the ordinary and usual course of business of the Group; (ii) on normal commercial terms or better; and (iii) according to the relevant agreements governing such transactions on terms that are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

The Company's auditor has reported to the Board and confirmed that for the year ended 31 December 2024 (i) nothing has come to their attention that causes them to believe that the Continuing Connected Transactions have not been approved by the Board; (ii) for transactions involving the provision of goods or services by the Group, nothing has come to their attention that causes them to believe that the transactions were not, in all material respects, in accordance with the pricing policies of the Group; (iii) nothing has come to their attention that causes them to believe that the transactions were not entered into, in all material respects, in accordance with the relevant agreements governing such transactions; and (iv) nothing has come to their attention that causes them to believe that the aggregate amount of the Continuing Connected Transactions as disclosed in note 28 to the consolidated financial statements have exceeded the annual cap as disclosed in the Company's announcement dated 28 December 2022.

#### **COMPETING INTERESTS**

Based on the confirmations received from each of the Directors, none of the Directors, controlling shareholder of the Company nor their respective close associates (as defined in the Listing Rules) had interests in any business which competes or is likely to compete, directly or indirectly, with the Group's businesses during the year ended 31 December 2024, and is required to be disclosed pursuant to Rule 8.10 of the Listing Rules.

#### PERMITTED INDEMNITY PROVISIONS

The Company has arranged for appropriate insurance coverage for Directors' and officers' liabilities in respect of legal actions against its Directors and senior management arising from corporate activities. Such permitted indemnity provision has been in force throughout the year ended 31 December 2024 and at the time of approval of this annual report.

Pursuant to the Articles, every Director shall be entitled to be indemnified and secured harmless out of the assets of the Company from and against all actions, costs, charges, losses, damages and expenses which they or any of them, shall or may incur or sustain by reason of any act done, concurred in or omitted in or about the execution of their duty or supposed duty in their respective offices, except such (if any) as they shall incur or sustain through their own fraud or dishonesty.

#### **SHARE OPTION SCHEME**

The share option scheme was adopted by the Company on 21 September 2017 (the "Share Option Scheme") and effective for a period of ten years to 20 September 2027. It is a share incentive scheme established to recognise and acknowledge the contributions that the eligible participants have or may have made to the Group. Pursuant to the Share Option Scheme, the Board may, at its discretion, offer to grant an option to any director, employee (full-time and part-time), advisor, consultant, supplier, customer, distributor, contractor, agent, business partner or service providers of the Group and to promote the success of the business of the Group.

Pursuant to the terms of the Share Option Scheme and in compliance with the provisions in Chapter 17 of the Listing Rules, the maximum number of Shares which may be issued upon exercise of all share options to be granted under the Share Option Scheme and all share option schemes of the Company shall not exceed 140,000,000 Shares, being 10% of the 1,400,000,000 Shares of the Company in issue as at 12 October 2017, being the date the Shares were listed on the Stock Exchange. The Company may issue a circular to the Shareholders and seek approval from the Shareholders in general meeting for refreshing the 10% limit such that the total number of Shares which may be issued upon the exercise of all options to be granted under the Share Option Scheme and any other share option schemes shall not exceed 10% of the total number of Shares in issue as at the date of the approval from the Shareholders.

#### 競爭權益

#### 獲准許彌償條文

本公司已就其董事及高級管理層可能面對因企業活動產生之法律訴訟,就董事及高級職員之責任作出適當的保險安排。有關獲准許彌償條文於截至二零二四年十二月三十一日止整個年度及於本年報獲批准時一直有效。

根據細則,各董事於執行或關於執行各自職務而於履行職 責或假定職責時作出、同意或遺漏之任何行為所將會或可 能招致或蒙受的所有訴訟、費用、收費、損失、損害賠償及 開支,可獲確保免就此受任何損害,惟彼等因欺詐或不誠 實而招致或蒙受者(如有)除外。

#### 購股權計劃

本公司購股權計劃(「購股權計劃」)於二零一七年九月二十一日獲採納及有效期為十年至二零二七年九月二十日。該計劃為一項股份獎勵計劃,旨在表彰及認可合資格參與者對本集團已作出或可能作出的貢獻。根據購股權計劃,董事會可酌情向任何本集團董事、僱員(全職及兼職)、顧問、專家顧問、供應商、客戶、分包商、承建商、代理、業務夥伴或服務供應商授出購股權,並促進本集團業務成功。

根據購股權計劃的條款及遵守上市規則第17章的條文,於行使購股權計劃及本公司所有其他購股權計劃下授出的所有購股權時可予發行的最高股份數目不得超過140,000,000股,即於二零一七年十月十二日(即股份於聯交所上市的日期)本公司已發行1,400,000,000股股份的10%。本公司可向股東寄發通函並尋求股東於股東大會上批准更新10%的限額,惟根據購股權計劃及任何其他購股權計劃將授出的全部購股權獲行使而可能發行股份的總數不得超過於股東批准日期已發行股份總數的10%。

The total number of Shares issued and which may fall to be issued upon exercise of the options granted under the Share Option Scheme to eligible participants in any 12 months period up to the date of grant shall not exceed 1% of the Shares in issue as at the date of grant, any further grant of options in excess of this 1% limit shall be subject to the approval of Shareholders in a general meeting.

The subscription price of a Share in respect of any particular option granted under the Share Option Scheme shall not be less than the highest of: (i) the closing price of the Shares as stated in the Stock Exchange's daily quotation sheets on the date of grant, which must be a trading date; (ii) the average of the closing prices of the Shares as stated in the Stock Exchange's daily quotation sheets for the five trading dates immediately preceding the date of grant; or (iii) the nominal value of a Share.

A share option may be exercised in accordance with the terms of the Share Option Scheme at any time during the period to be determined and notified by the Board to the participant at the time of making an offer for the grant of share option.

The total number of securities available for issue under the Share Option Scheme, and all other share option schemes of the Company must not exceed 140,000,000 Shares, representing 8.33% of the total number of Shares as at the date of this annual report.

No share options have been granted under the Share Option Scheme since 21 September 2017. An offer of the grant of a share option shall be accepted by the eligible participants within a period of twenty-one days from the date of offer of grant of share option. The consideration paid by each grantee for the acceptance and grant of each share option is HK\$1.00, which has to be paid within twenty-one days.

There were no options outstanding as at 31 December 2024 (31 December 2023: nil) and no share options were granted, exercised, cancelled or lapsed during the year ended 31 December 2024. As at 1 January 2024, the number of share options available for grant under the Share Option Scheme was 140,000,000 share options. As at 31 December 2024, there were 140,000,000 share options available for grant thereunder. There was no service provider sublimit set under the Share Option Scheme. For further details of the Share Option Scheme, please refer to the paragraph headed "D. Share Option Scheme" in Appendix IV to the prospectus of the Company dated 28 September 2017.

#### **DONATIONS**

The Group's charitable donations during the year ended 31 December 2024 amounted to approximately HK\$30,000 (2023: approximately HK\$30,000).

#### **EQUITY LINKED AGREEMENTS**

Save as disclosed in this annual report in relation to the Share Option Scheme, no equity-linked agreements were entered into for the year ended 31 December 2024.

#### **MAJOR CUSTOMERS AND SUPPLIERS**

For the year ended 31 December 2024, the percentage of the Group's total revenue attributable to the Group's largest customer and the five largest customers in aggregate accounted for approximately 48.3% and 80.5% (2023: approximately 51.6% and 76.6%) respectively. The percentage of the Group's total purchases from the Group's largest supplier and the five largest suppliers in aggregate accounted for approximately 26.3% and 78.1% (2023: approximately 38.7% and 51.0%) respectively for the year ended 31 December 2024

To the best of the Directors' knowledge, none of the Directors nor their close associates (as defined in the Listing Rules), nor any Shareholders (which, to the best knowledge of the Directors, owns more than 5% of the Company's total number of issued Shares) had any beneficial interest in any of the Group's five largest customers or suppliers.

# KEY RELATIONSHIPS WITH EMPLOYEES, CUSTOMERS, SUPPLIERS AND SUBCONTRACTORS

#### **Employees**

The Group has maintained good relationship with employees. In addition, the Group offers employees competitive salaries, bonuses and other cash subsidies. In general, the Group determines employee salaries based on each employee's qualifications, position and seniority. The Group has designed an annual review system to assess the performance of employees, which forms the basis of the decisions with respect to salary increments, bonuses and promotions.

#### **Customers**

The Group has established stable business relationship with major customers in construction and engineering services who are mostly Government departments including Civil Engineering and Development Department of the Government, Water Supplies Department and Highways Department. Among the five largest customers (in terms of revenue) during the year ended 31 December 2024, the Group has been providing services to most of them for a period ranging from three to twenty-three years. The Group will therefore endeavour to accommodate their demands for the Group's services to the extent that the Group's resources allow in order to capture more opportunities for larger scale projects in the future. The Group's experience as a quality contractor in construction and engineering industry provides the Group's customers certain business advantages to ensure that their projects are executed in accordance with quality standards.

## 主要客戶及供應商

截至二零二四年十二月三十一日止年度,本集團最大客戶及五大客戶合共應佔的收益分別佔本集團收益總額約48.3%及80.5%(二零二三年:佔約51.6%及76.6%)。本集團最大供應商及五大供應商合共應佔的採購總額分別佔本集團於截至二零二四年十二月三十一日止年度採購總額分別約26.3%及78.1%(二零二三年:約38.7%及51.0%)。

就董事所深知,董事、彼等緊密聯繫人(定義見上市規則) 以及任何股東(就董事所深知,擁有本公司已發行股本總數 5%以上)概無於本集團五大客戶或供應商中擁有任何實益 權益。

#### 與僱員、客戶、供應商及分包商的主要 關係

#### 僱員

本集團已與我們的僱員維持良好的關係。此外,本集團向僱員提供具競爭力的薪金、花紅及其他現金補貼。一般而言,本集團根據各僱員的資歷、職位及年資釐定僱員薪金。本集團已制定年度檢討機制以評估僱員的表現,此機制亦是我們作出有關提升薪金、花紅及升職決定的基準。

#### 客戶

本集團與建築及工程服務的主要客戶建立了穩定的業務關係,該等客戶大部分為政府部門,包括土木工程拓展署、水務署及路政署。於截至二零二四年十二月三十一日止年度的五大客戶中(按收益計),本集團已向其提供為期介乎三至二十三年的服務。因此,只要本集團資源允許,本集團將致力滿足其對本集團服務的需求,從而於日後為更大型項目捕捉更多機遇。本集團(作為優質承包商)於建築和工程行業的經驗,給予客戶業務優勢,可確保其項目根據其質量標準執行。

#### **Suppliers and subcontractors**

The Group maintains an internal list of approved suppliers in its construction and engineering services. The Group carefully evaluates the performance of suppliers and select them based on a number of factors such as their prices, quality, past performances and timeliness of delivery. The Group will review and update the internal list of approved suppliers according to assessment of their performances on an ongoing basis.

The Group maintains an internal list of approved subcontractors in its construction and engineering services. The Group carefully evaluates the performance of subcontractors and select subcontractors based on a number of factors such as their background, technical capability, experience, fee quotations, service quality, track records, labour resources, timeliness of delivery, reputation and safety performance. The Group will review and update the internal list of approved subcontractors according to assessment of their performances on an ongoing basis.

Subject to the Group's capacity, resources level, cost effectiveness, complexity of the projects and customers' requirements, the Group may subcontract civil engineering works such as geotechnical works, drainage works, earthworks, concreting, formwork erection, fixing steel bar and landscaping to other subcontractors in a project. The Group is accountable to customers for the works subcontracted to the Group's subcontractors.

The Directors consider that the long-term business relationships with major customers, suppliers and subcontractors would further enhance the Group's market recognition and enable the Group to attract more potential business opportunities.

#### **RETIREMENT SCHEME**

The Group operates a Mandatory Provident Fund Scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance and Nation Social Security Fund Scheme (the "SSF Scheme") under the Nation Social Security Law of Cambodia for our employees in Hong Kong and Cambodia respectively.

The MPF scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the plan vest fully and immediately with the employees once the contributions to the plan are made. As at 31 December 2024 and 2023, no forfeited contributions were available for utilisation by the Group to reduce the existing level of contributions. Under the SSF Scheme, the employer and its employees are required to make contributions to the plan at 4% of the employee's relevant income subject to a cap of monthly relevant income of KHR 1.2 million (approximately HK\$2,340). Save as the aforesaid, the Group did not participate in any other pension schemes during the year ended 31 December 2024.

#### 供應商及分包商

本集團備存一份建築及工程服務的認可供應商的內部名單。 本集團根據多種因素審慎評估供應商的表現及甄選供應商, 例如其價格、質素、過往表現及交付時間。本集團根據供 應商的表現評估,持續檢討及更新認可供應商內部名單。

本集團備存一份建築及工程服務的認可分包商的內部名單。 本集團根據多種因素審慎評估分包商的表現及甄選分包商, 例如其背景、技術能力、經驗、費用報價、服務質素、往績 記錄、勞工資源、交付時間、聲譽及安全表現。本集團將根 據分包商的表現評估,持續檢討及更新認可分包商內部名單。

根據本集團的負荷量、資源水平、成本效益、項目複雜性及客戶的要求,本集團可將某個項目的土木工程(如岩土技術工程、渠務工程、土方工程、混凝土模板、豎立模板、安裝鋼筋及綠化)分包予其他分包商。本集團就分包予本集團分包商的工程對客戶負責。

董事認為,我們與主要客戶、供應商及分包商的長期業務 關係可進一步提升本集團的市場知名度並使得本集團吸引 更多潛在業務機會。

#### 退休計劃

本集團根據香港強制性公積金計劃條例及柬埔寨國家社會保障法分別為我們於香港及柬埔寨的僱員提供强制性公積金計劃(「強積金計劃」)及國家社會保障基金計劃(「社會保障基金計劃」)。

強積金計劃乃為由獨立受託人管理的定額供款退休計劃。根據強積金計劃,僱主及僱員須各自按僱員相關收入的5%向計劃作出供款,上限為每月相關收入30,000港元。每當對計劃作出供款,即計劃供款會即時全數歸屬於僱員。於二零二四年及二零二三年十二月三十一日,並無沒收供款可供本集團使用以降低現有供款水平。根據社會保障基金計劃,僱主及僱員合共需按照僱員相關收入的4%向計劃作出供款,上限為每月相關收入1,200,000瑞爾(約2,340港元)。除上文所述者外,於截至二零二四年十二月三十一日止年度,本集團並無參與任何其他退休金計劃。

#### SUFFICIENCY OF PUBLIC FLOAT

Based on the information that is publicly available to the Company and within the knowledge of the Directors, the Directors confirmed that the Company has maintained a sufficient level of public float for its Shares as required under the Listing Rules during the year ended 31 December 2024 and up to the date of this annual report.

# PURCHASE, SALE AND REDEMPTION OF THE COMPANY'S LISTED SECURITIES

No purchase, sale or redemption of the Company's listed securities was made by the Company or any of its subsidiaries during the year ended 31 December 2024.

#### **PRE-EMPTIVE RIGHTS**

There is no provision for pre-emptive rights under the Articles and there is no restriction against such rights under the laws of the Cayman Islands, which would oblige the Company to offer new shares on a pro-rata basis to the existing Shareholders.

#### **TAX RELIEF**

The Company is not aware of any relief from taxation available to the Shareholders by reason of their holding of the Shares. Intending holders and investors of the Company's shares are recommended to consult their professional advisers if they are in any doubt as to the taxation implications (including tax relief) of subscribing for, purchasing, holding, disposing of or dealing in shares. It is emphasised that none of the Company or its Directors or officers will accept any responsibility for any tax effect on, or liabilities of, holders of Shares in the Company resulting from their subscription for, purchase, holding, disposal of or dealing in such shares.



#### **OPINION**

We have audited the consolidated financial statements of Geotech Holdings Ltd. (the "Company") and its subsidiaries (together, the "Group") set out on pages 93 to 170, which comprise the consolidated statement of financial position as at 31 December 2024, and the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information.

#### **Accounting for construction contracts**

Refer to the summary of material accounting policies in Note 2.14, Note 4a and Note 5 to the consolidated financial statements.

#### **Key Audit Matter**

The Group recognised revenue and costs from construction contracts amounted to approximately HK\$61,129,000 and HK\$60,529,000 respectively for the year ended 31 December 2024.

The Group's revenue and costs of construction contracts are recognised based on output method by reference to the direct measurements of the value of the services transferred to the customer to date relative to the remaining services promised under the contract. The value of the services transferred to customer to date is measured according to the progress certificate (by reference to the • construction works certified by the customers or their agents). When the outcome of a construction contract cannot be estimated reliably, contract revenue is recognised only to the extent of contract costs incurred that are . likely to be recoverable.

#### How our audit addressed the Key **Audit Matter**

Our audit procedures in relation to the accounting of construction contracts included the following:

- Understood the basis of estimation of the budgets through discussion with the management who is responsible for the budgeting of the construction contracts, and evaluated the reasonableness of the estimated profit margins by taking into account of the profit margins of historical similar projects;
  - Inspected the key terms and conditions of construction contracts and verify the total contract revenue.
- Assessed and checked, on a sample basis, the accuracy of the budgeted construction revenue by agreeing to contract sum or variation orders as set out in the construction contracts or the agreements entered with customers;

Refer to the summary of material accounting policies in Note 2.7, Note 4b, Note 17 and Note 18 to the consolidated financial statements.

#### **Key Audit Matter**

As at 31 December 2024, the Group's carrying amount of trade and other receivables a (excluding prepayment) and contract assets amounted to approximately HK\$48,770,000 (net of impairment under ECL allowance of HK\$10,305,000) and HK\$6,832,000 (net of impairment under ECL allowance of HK\$6,000) respectively, accounted for approximately 29.5% of the Group's total assets in aggregate.

The ECL assessment of trade and other receivables and contract assets involved significant management's judgement and use of estimates to ascertain the recoverability.

Management performed credit evaluations for the Group's customers and assessed ECL. These evaluations focused on the past history, existing market conditions as well as forward-looking estimates at the end of each reporting period.

We have identified the ECL assessment of trade and other receivables and contract assets as a key audit matter because of its significance to the consolidated financial statements and the assessment involves significant management's judgement and use of estimates in evaluation of ECL.

#### How our audit addressed the Key Audit Matter

Our audit procedures in relation to the ECL assessment of trade and other receivables and contract assets included the following:

- Understood, evaluated and validated the design and operating effectiveness of the controls over impairment assessment of trade and other receivables and contract assets. Those controls related to the identification of events that triggered the provision for impairment of receivables from construction contracts and estimation of the impairment provisions;
- Obtained management's assessment on the collectability of individual significant customers, and corroborated management's assessment against relevant supporting evidence, including credit history and financial capability of these customers;
  - Assessed the reasonableness of management's ECL allowance estimates by examining the information used by management to form such judgements, including testing the accuracy of the historical default data, evaluating whether the historical loss rates are appropriately adjusted based on current economic conditions and forward-looking information; and
- Involved the valuation specialist to review the management's estimation on ECI

#### 1. GENERAL INFORMATION

Geotech Holdings Ltd. (the "Company") was incorporated as an exempted company with limited liability in the Cayman Islands under the Companies Law (as revised) of the Cayman Islands and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The address of the registered office is Windward 3, Regatta Office Park, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands, and its principal place of business is Unit 706–708, 7th Floor, Tower II, Metroplaza, 223 Hing Fong Road, Kwai Chung, New Territories, Hong Kong.

The Company is an investment holding company, and its subsidiaries (collectively referred to as the "**Group**") are principally engaged in provision of construction and engineering services, property-related services and sales of luxury products.

The Company's immediate and ultimate holding company is Star Merit Global Limited ("Star Merit"), a company incorporated in the British Virgin Islands (the "BVI") and wholly owned by Mr. Chen Zhi ("Mr. Chen"). The ultimate controlling shareholder of the Company is Mr. Chen.

These consolidated financial statements for the year ended 31 December 2024 (the "Consolidated Financial Statements") were approved for issue by the board of directors (the "Directors") of the Company on 24 March 2025.

#### 2. SUMMARY OF MATERIAL ACCOUNTING POLICIES

#### 2.1 Basis of preparation

The annual consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards as issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), which collective term includes all applicable individual HKFRS accounting standards, Hong Kong Accounting Standards and Interpretations ("HKFRS Accounting Standards") and the accounting principles generally accepted in Hong Kong.

The consolidated financial statements also comply with the applicable disclosure requirements of the Hong Kong Companies Ordinance and include the applicable disclosure requirements of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules").

The material accounting policies that have been used in the preparation of these consolidated financial statements are summarised below. These policies have been consistently applied to all the years presented in the consolidated financial statements. The adoption of new or amended HKFRS Accounting Standards and the impacts on the Group's consolidated financial statements, if any, are disclosed in Note 3.

#### 1. 一般資料

致浩達控股有限公司(「本公司」)於開曼群島根據開曼群島公司法(經修訂)註冊成立為一間獲豁免有限公司,其股份於香港聯合交易所有限公司(「聯交所」)主板上市。註冊辦事處地點為Windward 3, Regatta Office Park, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands,及其主要營業地點為香港新界葵涌興芳路223號新都會廣場2座7樓706-708室。

本公司為一間投資控股公司,其附屬公司(統稱 「本集團」)主要從事提供建築及工程服務、物業相關 服務及奢侈品銷售。

本公司的直接及最終控股公司為星優環球有限公司 (「星優」,一間於英屬處女群島(「英屬處女群島」)註 冊成立的公司並由陳志先生(「陳先生」)全資擁有)。 本公司最終控股股東為陳先生。

截至二零二四年十二月三十一日止年度之該等綜合財務報表(「綜合財務報表」)已於二零二五年三月二十四日獲本公司董事(「董事」)會批准刊發。

#### 2. 重大會計政策概要

#### 2.1 編製基準

年度綜合財務報表乃按照香港會計師公會頒佈的香港財務報告準則編製,其統稱包括所有適用的個別香港財務報告準則會計準則、香港會計準則及詮釋(「香港財務報告準則會計準則」)以及香港公認會計原則。

綜合財務報表亦符合香港公司條例之適用之 披露規定及包括香港聯合交易所有限公司證 券上市規則(「**上市規則**」)之適用披露規定。

編製該等綜合財務報表所採用的重大會計政策概述於下文。該等政策已貫徹應用於綜合財務報表所呈列的所有年度。採納新訂或經修訂香港財務報告準則會計準則及對本集團綜合財務報表之影響(如有)披露於附註3。

#### 2.1 Basis of preparation (Continued)

The consolidated financial statements have been prepared on the historical cost basis except for financial assets at fair value through other comprehensive income ("FVOCI") which are stated at fair value. The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the functional currency of the Company, and all values are rounded to the nearest thousands ("HK\$'000"), except when otherwise indicated.

It should be noted that accounting estimates and assumptions are used in preparation of the consolidated financial statements. Although these estimates are based on management's best knowledge and judgment of current events and actions, actual results may ultimately differ from those estimates. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in Note 4.

#### 2.2 Basis of consolidation

The consolidated financial statements incorporates the financial statements of the Company and its subsidiaries. The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies.

Subsidiaries are entities controlled by the Group. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power over the entity, only substantive rights relating to the entity (held by the Group and others) are considered.

The Group includes the income and expenses of a subsidiary in the consolidated financial statements from the date it gains control until the date when the Group ceases to control the subsidiary.

Intra-group transactions, balances and unrealised gains and losses on transactions between group companies are eliminated in preparing the consolidated financial statements. Where unrealised losses on sales of intragroup asset are reversed on consolidation, the underlying asset is also tested for impairment from the Group's perspective. Amounts reported in the financial statements of subsidiaries have been adjusted where necessary to ensure consistency with the accounting policies adopted by the Group.

綜合財務報表乃按歷史成本基準編製,惟按公平值計入其他全面收益之金融資產乃按公平值呈列。綜合財務報表以港元(本公司功能貨幣)呈列,除另有指明者外,所有金額均約整至最接近的千位(「千港元」)。

謹請留意編製綜合財務報表時已使用會計估計及假設。儘管該等估計乃基於管理層對目前事件及措施的最佳瞭解及判斷作出,但實際結果最終可能與該等估計有異。涉及較高程度判斷或複雜性的領域或假設及估計對綜合財務報表屬重大的領域披露於附註4。

#### 2.2 綜合基準

綜合財務報表包括本公司及其附屬公司的財 務報表。附屬公司編製財務報表的報告期間 及採用的會計政策與本公司相同。

附屬公司為由本集團控制的實體。本集團承受或享有參與實體所得的可變回報,且有能力透過其對實體的權力影響該等回報時,則本集團控制該實體。於評估本集團對實體是否擁有權力時,僅會考慮與實體(由本集團及他人持有)有關的實質權利。

本集團的綜合財務報表包括附屬公司自本集 團取得控制權之日起至不再控制該附屬公司 之日的收入及開支。

集團內公司間交易、集團公司間交易結餘及 未變現收益及虧損於編製綜合財務報表時予 以抵銷。而集團間之未變現資產銷售虧損於 綜合入賬時撥回,本集團亦會對相關資產進 行減值測試。附屬公司的財務報表的申報金 額已作必要調整,以確保與本集團採用的會 計政第一致。

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest; and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests.

In the Company's statement of financial position, subsidiaries are carried at cost less any impairment loss unless the subsidiary is held for sale or included in a disposal group. Cost also includes directly attributable costs of investment.

The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable at the reporting date. All dividends whether received out of the investee's pre or post-acquisition profits are recognised in the Company's profit or loss.

#### 2.3 Joint operations

A joint arrangement is a contractual arrangement between the Group and other parties, where they have contractually agreed to share joint control, which exists only when decisions about relevant activities require the unanimous consent of the parties sharing control. A joint arrangement is either a joint operation or a joint venture.

A joint operation is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the assets, and obligations for the liabilities, relating to the arrangement. The Group recognises its interest in the joint operation by combining the assets, liabilities, revenues and expenses relating to its interest with similar items on a line by line basis. Consistent accounting policies are applied for like transactions and events in similar circumstances. The Group recognises its interest in the joint operation from the date that joint control commences until the date on which the Group ceases to have joint control over the joint operation. Unrealised profits and losses resulting from transactions between the Group and its joint operations are eliminated to the extent of the Group's interest in the joint operation, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss. When the Group ceases to have joint control over the joint operation, it is accounted for as a disposal of the entire interest in the joint operation, with a resulting gain or loss being recognised in profit or loss.

除非附屬公司乃持作出售或計入出售組別, 否則本公司的財務狀況表中,附屬公司按成本值扣除任何減值虧損列賬。成本亦包括投資直接應佔的成本。

附屬公司的業績由本公司按於報告日期已收 及應收股息的基準列賬。不論所收取股息是 以投資對象的收購前或收購後溢利作出,全 部股息均於本公司的損益中確認。

#### 2.3 合營經營

合營安排為本集團與其他方之間的合約安排, 彼等按照約定共有控制權,而該控制權僅在 相關活動必須經過分享控制權的各方一致同 意後才能決策時存在。合營安排為合營經營 或合營企業。

合營經營為一項合營安排,據此,對該安排共 有控制權之各方享有對該安排相關資產之權 利以及負有對該安排相關負債之責任。本集 團透過按分項總計基準將其權益相關之資產、 負債、收益及開支與類似項目合併以確認於 合營經營之權益。類似交易及類似情況下之 事件均應用一致的會計政策。本集團自共同 控制權開始之日起至本集團不再對合營經營 擁有共同控制權之日止確認其於合營經營之 權益。本集團與其合營經營之間的交易所產 生之未變現溢利及虧損以本集團於該合營經 營之權益為限予以對銷,除非未變現虧損能 夠證實所轉讓之資產出現減值則作別論,在 該情況下,該等虧損隨即於損益中確認。當本 集團不再對合營經營擁有共同控制權時,此 入賬列為於合營經營之全部權益出售,相應 產生之收益或虧損於損益中確認。

#### 2.4 Foreign currency translation

In the individual financial statements of the consolidated group entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated (i.e. only translated using the exchange rates at the transaction date).

When a fair value gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is also recognised in profit or loss. When a fair value gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is also recognised in other comprehensive income.

#### 2.5 Property, plant and equipment

Property, plant and equipment (other than cost of right-of-use assets (as described in Note 2.11)) are initially recognised at acquisition cost, includes expenditure that is directly attributable to the acquisition of the asset. Purchased software that is integral to the functionality of the related equipment is capitalised as part of that equipment. They are subsequently stated at cost less accumulated depreciation and impairment losses. Depreciation commences when the assets are ready for their intended use.

Depreciation is provided to write off the cost of assets less their residual values, if any over their estimated useful lives, using the straight-line method, at the following rates per annum:

Plant and machinery30%Motor vehicles20% to 30%Furniture and fixtures20%Leasehold improvement331/3% to 50%Computer and software20% to 30%

Accounting policy for depreciation of right-of-use assets is set out in Note 2.11.

Estimates of the assets' residual values, depreciation methods and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

按公平值入賬及以外幣計值之非貨幣項目按 釐定公平值當日之適用匯率換算。以外幣計值 按歷史成本計量之非貨幣項目概不重新換算(即 僅使用交易日期的匯率換算)。

#### 2.5 物業、廠房及設備

物業、廠房及設備(附註2.11所述之使用權資產成本除外)乃按購入成本初步確認。成本包括資產收購直接應佔的開支。所購軟件(作為相關設備運作的必備部分)視為該設備一部分撥充資本。其後則按成本減累計折舊及減值虧損列賬。當有關資產準備作擬定用途時開始計算折舊。

The gain or loss arising on retirement or disposal is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other costs, such as repairs and maintenance, are charged to profit or loss during the financial period in which they are incurred.

#### 2.6 Financial instruments

#### Recognition and derecognition

Financial assets are recognised when the Group becomes a party to the contractual provisions of the financial instrument.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and substantially all of its risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

#### **Financial assets**

#### Classification and initial measurement of financial assets

Except for those trade receivables and retention receivables that do not contain a significant financing component and are measured at the transaction price in accordance with HKFRS 15, "Revenue from Contracts with Customers", all financial assets are initially measured at fair value, in case of a financial asset not at fair value through profit or loss ("FVTPL"), plus transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVTPL are expensed in the consolidated statement of profit or loss and other comprehensive income.

Financial assets, other than those designated and effective as hedging instruments, are classified into the following categories:

- amortised cost;
- FVTPL: or
- FVOCI

HKFRS 9's impairment requirements use more forward-looking information to recognise ECL — the "ECL model". Instruments within the scope included trade receivables, retention receivables, contract assets recognised and measured under HKFRS 15 and other financial assets measured at amortised cost.

The Group considers a broader range of information when assessing credit risk and measuring ECL, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk ("Stage 1"); and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low ("Stage 2").

"Stage 3" would cover financial assets that have objective evidence of impairment at the reporting date.

"12-month ECL" are recognised for the Stage 1 category while "lifetime ECL" are recognised for the Stage 2 category.

Measurement of the ECL is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

# Trade receivables, finance lease receivables, retention receivables and contract assets

For trade receivables, finance lease receivables, retention receivables and contract assets, the Group applies a simplified approach in calculating ECL and recognises a loss allowance based on lifetime ECL at each reporting date. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial assets. In calculating the ECL, the Group has established a provision matrix that is based on its historical credit loss experience and external indicators, adjusted for forward-looking factors specific to the debtors and the economic environment.

To measure the ECL, trade receivables, finance lease receivables, retention receivables and contract assets have been grouped based on shared credit risk characteristics and the days past due. The contract assets relate to unbilled work in progress and have substantially the same risk characteristics as the trade receivables for the same types of contracts. The Group has therefore concluded that the ECL rates for trade receivables are a reasonable approximation of the loss rates for the contract assets.

#### Other financial assets measured at amortised cost

The Group measures the loss allowance for other receivables measured at amortised cost on an individual basis for significant balance and equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood of risk of default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial assets at the reporting date with the risk of default occurring on the financial assets at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk,
   e.g. a significant increase in the credit spread, the credit default
   swap prices for the debtor;
- existing or forecast adverse changes in business, financial, economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obliqations;
- an actual or expected significant deterioration in the operating results of the debtor; or
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the end of each reporting period. A debt instrument is determined to have low credit risk if it has a low risk of default, the borrower has strong capacity to meet its contractual cash flow obligations in the near term and adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations.

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collateral held by the Group).

### 2.8 Impairment of non-financial assets

Property, plant and equipment (including right-of-use assets) and the Company's interests in subsidiaries are subject to impairment testing. They are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. Recoverable amount is the higher of fair value, reflecting market conditions less costs of disposal, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e., a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level.

Impairment loss recognised for cash-generating units is charged pro rata to the assets in the cash generating unit, except that the carrying amount of an asset will not be reduced below its individual fair value less cost of disposal, or value in use, if determinable.

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

A contract asset is recognised when the Group recognises revenue (see Note 2.14) before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for ECL in accordance with the policy set out in Note 2.7 and are reclassified to receivables when the right to the consideration has become unconditional.

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue (see Note 2.14). A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised.

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

### 2.10 Cash and cash equivalents

Cash and cash equivalents include cash at bank and in hand, demand deposits with banks and short term highly liquid investments with original maturities of three months or less that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value

At lease commencement date, the Group recognises a right-of-use asset and a lease liability on the consolidated statement of financial position. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Group, an estimate of any costs to dismantle and remove the underlying asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any lease incentives received).

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable payments based on an index or rate, and amounts expected to be payable under a residual value guarantee. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payment of penalties for terminating a lease, if the lease term reflects the Group exercising the option to terminate.

Subsequent to initial measurement, the liability will be reduced for lease payments made and increased for interest cost on the lease liability. It is remeasured to reflect any reassessment or lease modification, or if there are changes in in-substance fixed payments.

When the lease is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

The Group has elected to account for short-term leases using the practical expedients. Refundable rental deposits paid are accounted for under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

#### (b) The Group as a lessor

As a lessor, the Group classifies its leases as either operating or finance leases.

A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset, and classified as an operating lease if it does not.

When the Group is an intermediate lessor, it accounts for the head lease and the sub-leases as two separate contracts. The sub-leases are classified as a finance or operating lease with reference to the right- of-use asset arising from the head lease, not with reference to the underlying asset. If the head lease is a short-term lease to which the Group applies the short-term lease exemption, then the Group classifies the sub-lease as an operating lease.

The Group sub-leases some of its premises and the sub-lease contracts are classified as finance lease.

### Assets leased out under operating leases as the lessor

Assets leased out under operating leases are measured and presented according to the nature of the assets. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense over the lease term on the same basis as the rental income.

Rental income receivable from operating leases is recognised in profit or loss on a straight-line basis over the periods covered by the lease term, except where an alternative basis is more representative of the time pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable.

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

An onerous contract exists when the Group has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received from the contract. Provisions for onerous contracts are measured at the present value of the lower of the expected cost of terminating the contract and the net cost of fulfilling the contract (which includes both incremental costs and an allocation of other costs that relate directly to fulfilling that contract).

### 2.13 Share capital

Ordinary shares are classified as equity. Share capital is determined using the nominal value of shares that have been issued. Any transaction costs associated with the issuing of shares (net of any related income tax benefit) to the extent they are incremental costs directly attributable to the equity transaction are deducted from the share premium.

### 2.14 Revenue recognition

Revenue arises mainly from the contracts for the construction services and sales income

To determine whether to recognise revenue, the Group follows a 5-step process:

- 1. Identifying the contract with a customer;
- 2. Identifying the performance obligations;
- 3. Determining the transaction price;
- 4. Allocating the transaction price to the performance obligations; and
- Recognising revenue when/as performance obligation(s) are satisfied.

In all cases, the total transaction price for a contract is allocated amongst the various performance obligations based on their relative stand-alone selling prices. The transaction price for a contract excludes any amounts collected on behalf of third parties.

Revenue is recognised either at a point in time or over time, when (or as) the Group satisfies performance obligations by transferring the promised goods or services to its customers.

Further details of the Group's revenue and other income recognition policies are as follows:

#### **Construction contracts**

Revenue from construction contracts are recognised over time as the Group's performance creates and enhances an asset that the customer controls which referred as the designated areas where the construction work services performed. The progress towards complete satisfaction of a performance obligation is measured based on output method, which is to recognise revenue on the basis of direct measurements of the value of the services transferred to the customer to date relative to the remaining services promised under the contract, that best depict the Group's performance in transferring control of services. The value of the services transferred to customer to date is measured according to the progress certificate (by reference to the construction works certified by the customers or their agents).

#### Construction contracts (continued)

Contract costs are recognised when incurred. When the outcome of a construction contract cannot be estimated reliably, contract revenue is recognised only to the extent of contract costs incurred that are likely to be recoverable.

If at any time the costs to complete the contract are estimated to exceed the remaining amount of the consideration under the contract, a provision is recognised in accordance with HKAS 37 "Provisions, Contingent Liabilities and Contingent Assets".

The Group generally provides warranties for repairs to any construction defects and does not provide extended warranties in its construction contract with customers. As such, most existing warranties are considered as assurance-type warranties under HKFRS 15, which are accounted for under HKAS 37. Retention receivables are reclassified to trade receivables when the retention period expires.

### Sales income

Revenue from the sales of watches for a fixed fee is recognised when or as the Company transfers control of the assets to the customer. Invoices for goods transferred are due upon receipt by the customer.

#### Interest income

Interest income is recognised on a time proportion basis using the effective interest method. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the assets. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of impairment under ECL allowance) of the asset.

#### Rental income

Accounting policies for rental income are set out in Note 2.11.

### Property management consultancy service income

The performance obligation to provide the property management consultancy service income are satisfied over time. Revenue is recognised over time on time proportion basis.

### 2.15 Employee benefits

#### **Retirement benefits**

Retirement benefits to employees are provided through defined contribution plans. In addition, the employees employed under the Hong Kong Employment Ordinance are also entitled to long service payment ("LSP") if the eligibility criteria are met. The LSP are defined benefits plans.

### (a) Defined contribution plans

The Group operates a defined contribution retirement benefit plan under the Mandatory Provident Fund Schemes Ordinance, for all of its employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries.

Contributions are recognised as an expense in profit or loss as employees render services during the year. The Group's obligations under these plans are limited to the fixed percentage contributions payable.

There were no contributions forfeited by the Group on behalf of its employees who left the plan prior to vesting fully in such contribution, nor had there been any utilisation of such forfeited contributions to reduce future contributions. As at 31 December 2024 and 2023, no forfeited contributions were available for utilisation by the Group to reduce the existing level of contributions.

#### (b) Defined benefit plans

The amount of long service benefit that an employee will receive on cessation of employment in certain circumstances is defined by reference to the employee's length of service and corresponding salary. The legal obligations for any benefits remains with the Group.

The LSP obligations recognised in the consolidated statement of financial position is the present value of the LSP obligation at the end of the reporting period.

Management estimates the LSP obligations annually. This is based on the discount rate, the salary growth rate and turnover rate. Discount factors are determined close to the end of each annual reporting period by reference to high quality corporate bonds that are denominated in the currency in which the benefits will be paid and have terms to maturity approximating the terms of the related defined benefit liability.

Defined benefit costs are categorised as follows:

- service cost (including current and past service cost, and gains and losses on curtailments and settlements);
- net interest expense or income; and
- remeasurement.

Service cost on the Group's defined benefit plan is included in employee benefits expense. Employee contributions, all of which are independent of the number of years of service, are treated as a reduction of service cost.

Net interest expense on the net defined benefit liability is included in employee benefits expenses.

Gains and losses resulting from remeasurements of the net defined benefit liability, comprising actuarial gains and losses, are included in other comprehensive income and are not reclassified to profit or loss in subsequent periods.

Short-term employee benefits

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

#### 2.16 Borrowing costs

Borrowing costs incurred, net of any investment income earned on the temporary investment of the specific borrowings, for the acquisition, construction or production of any qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use. A qualifying asset is an asset which necessarily takes a substantial period of time to get ready for its intended use or sale. Other borrowing costs are expensed when incurred.

#### 2.17 Accounting for income taxes

Income tax comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the reporting date between the carrying amounts of assets and liabilities in the financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss and does not give rise to equal taxable and deductible temporary differences.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies the requirements in HKAS 12 to the lease liabilities and the related assets separately. The Group recognises a deferred tax asset related to the lease liabilities to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised and a deferred tax liability for all taxable temporary differences.

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the reporting date.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly in equity.

When different tax rates apply to different levels of taxable income, deferred tax assets and liabilities are measured using the average tax rates that are expected to apply to the taxable income of the periods in which the temporary differences are expected to reverse.

### 2.18 Segment reporting

The Group identifies operating segments and prepares segment information based on the regular internal financial information reported to the chief operating decision maker (the "CODM") for their decisions about resources allocation to the Group's business components and for their review of the performance of those components. The business components in the internal financial information reported to the executive directors, being the CODM are determined following the Group's major services lines.

The Group has identified the following reportable segments:

- (a) Construction and engineering services;
- (b) Property-related services; and
- (c) Sales of luxury products.

Each of these operating segments is managed separately as each of the service lines requires different resources as well as marketing approaches. All inter-segment transfers are carried out at arm's length prices.

The measurement policies that the Group used for reporting segment results under HKFRS 8 "Operating Segments" are the same as those used in its financial statements prepared under HKFRS Accounting Standards, except that the following items are not included in arriving at the operating results of the operating segment:

- income tax; and
- corporate income and expenses which are not directly attributable to the business activities of any operating segment.

Segment assets include all assets but financial assets at FVOCI and corporate assets which are not directly attributable to the business activities of any operating segment and are not allocated to a segment, and which primarily applies to the Group's headquarters.

Segment liabilities exclude corporate liabilities which are not directly attributable to the business activities of any operating segment and are not allocated to a segment.

HKFRS 18 replaces HKAS 1 "Presentation of Financial Statements". HKFRS 18 will not impact the recognition and measurement of financial statements items but the presentation of them. It introduces three major new requirements, including:

  into five newly defined categories (namely "operating", "investing",

In the application of the Group's accounting policies, which are set out in Note 2, the management is required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future period if the revision affects both current and future periods.

### (a) Critical accounting judgements

The following are the critical judgements, apart from those involving estimations (see Note 4(b)), that the management has made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

### **Construction contracts**

As explained in Note 2.14, revenue recognition on a project is dependent on management's estimation of the total outcome of the construction contracts, with reference to the progress certificates issued by the customers or their agents. The Group reviews and revises the estimates of contract revenue, contract costs and variation orders (if any), prepared for each construction contract as the contract progresses. Budgeted construction costs are prepared by management on the basis of quotations from time to time provided by the major contractors, suppliers or vendors involved and the experience of management. In order to keep the budget accurate and up-to-date, management conducts periodic reviews of the budgeted construction costs by comparing the budgeted amounts to the actual costs incurred. When the outcome of a construction contract cannot be estimated reliably (uncertified work or unagreed income), contract revenue is recognised only to the extent of contract costs incurred that are likely to be recoverable.

Significant judgement is required in estimating the contract revenue, contract costs and variation work (if any) which may have an impact on progress of the construction contracts and the corresponding profit taken.

Management exercised their judgements and estimated contract costs and revenues with reference to the latest available information, which includes detailed contract sum and works performed. In many cases the results reflect the expected outcome of long-term contractual obligations which span more than one reporting period. Contract costs and revenues are affected by a variety of uncertainties that depend on the outcome of future events and often need to be revised as events unfold and uncertainties are resolved. The estimates of contract costs and revenues are updated regularly and significant changes are highlighted through established internal review procedures. In particular, the internal reviews focus on the timing and recognition of payments and the age and recoverability of any uncertified work and unagreed income from variations to the contract scope or claims. The impact of the changes in accounting estimates is then reflected in the ongoing results. Details of the contract assets and contract liabilities are disclosed in Note 18.

### Determination of the lease term in lease contracts and discount rate

In determining the lease term, management considers all facts and circumstances that create an economic incentive to exercise an extension options, or not exercise a termination option. Factors considered include:

- contractual terms and conditions for the optional periods compared with market rates (e.g. whether the amount of payments in the optional periods is below the market rates);
- the extent of leasehold improvements undertaken by the Group; and
- costs relating to termination of the lease (e.g. relocation costs, costs
  of identifying another underlying asset suitable for the Group's
  needs).

Extension options (or periods after termination options) are only included in the lease term if the lease is reasonably certain to be extended (or not terminated), which in turn affect the carrying amounts of lease liabilities and corresponding right-of-use assets.

During the year ended 31 December 2024, all extension options in leases of offices have not been included in determination of the lease liability because the Group could replace the assets without significant cost.

In addition, the Group exercised considerable judgement in relation to determining the discount rate taking into account the nature of the underlying assets and the terms and conditions of the leases, at both the commencement date and effective date of the modification.

### (b) Estimate uncertainty

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

# Estimation of impairment of trade and other receivables and contract assets within the scope of ECL

The Group makes allowances on items subject to ECL (including trade and other receivables and contract assets) based on assumptions about risk of default and expected credit loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward-looking estimates at the end of each reporting period as set out in Note 2.7 and Note 31.4. As at 31 December 2024, the aggregate carrying amounts of trade and other receivables (excluding prepayment) and contract assets amounted to HK\$48,770,000 (net of ECL allowance of HK\$10,305,000) (31 December 2023: HK\$46,947,000 (net of ECL allowance of HK\$11,813,000)) and HK\$6,832,000 (net of ECL allowance of HK\$19,000)) respectively. Details of the trade and other receivables and contract assets are disclosed in Note 17 and Note 18 respectively.

The provision of ECL is sensitive to changes in estimates. When the actual future cash flows are different from expected, such difference will impact the carrying amount of trade receivables and other items within the scope of ECL under HKFRS 9 and credit losses in the periods in which such estimate has been changed.

# Pursuant to the Hong Kong Employment Ordinance, Chapter 57, Hong Kong employees that have been employed continuously for at least five years are entitled to long service payment ("**LSP**") under certain circumstances (e.g. dismissal by employers or upon retirement).

The amount of LSP payable is determined with reference to the employee's last monthly salary (capped at HK\$22,500) and the years of service, reduced by the amount of any accrued benefits derived from the Group's contributions to MPF scheme, with an overall cap of HK\$390,000 per employee. Currently, the Group does not have any separate funding arrangement in place to meet its LSP obligations.

The Amendment Ordinance will take effect on 1 May 2025 (the "Transition Date"). Separately, the Government has indicated that it would launch a subsidy scheme to assist employers after the abolition

Among other things, once the abolition of the offsetting mechanism takes effect, an employer can no longer use any of the accrued benefits derived from its mandatory MPF contributions (irrespective of the contributions made before, on or after the Transition Date) to reduce the LSP in respect of an employee's service from the Transition Date. However, where an employee's employment commenced before the Transition Date, the employer can continue to use the above accrued benefits to reduce the LSP in respect of the employee's service up to that date. In addition, the LSP in respect of the service before the Transition Date will be calculated based on the employee's monthly salary immediately before the Transition Date and the years of service up to that date.

The benefit payment under LSP remains capped at HK\$390,000 per employee. If an employee's total benefit payment exceeds HK\$390,000, the amount in excess of the cap is deducted from the portion accrued from the Transition Date.

The Group has accounted for the offsetting mechanism and its abolition as disclosed in Note 2.15 to the consolidated financial statements.

The Group has determined that the Amendment Ordinance primarily impacts the Group's LSP obligations with respect to Hong Kong employees.

The Group's overall risk management strategy seeks to minimise potential adverse effects on the Group's financial performance. #### 31.2 Foreign currency risk

#### 31.2 外幣風險

Foreign currency risk refers to the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in foreign exchange rates. The Group's exposures to currency risk arise from its cash at bank denominated in United Stated Dollars ("**US\$**") amounted to approximately of HK\$37,847,000 as at 31 December 2024 (31 December 2023: HK\$37,088,000), which is not the functional currency of the relevant group entities. Since HK\$ are pegged to US\$ under the Linked Exchange Rate System, the management does not expect significant foreign currency exposure in relation to the exchange rate fluctuation between HK\$ and US\$.

#### 31.3 Interest rate risk

Interest rate risk relates to the risk that the fair value or cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Group's interest rate risk arises primarily from lease liabilities. Lease liabilities bearing fixed rate expose the Group to fair value interest rate risk and the exposure to the Group is considered immaterial.

The exposure to interest rate risk for the Group's bank balances is considered immaterial.

#### 31.4 Credit risk

Credit risk refers to the risk that the counterparty to a financial instrument would fail to discharge its obligation under the terms of the financial instrument and cause a financial loss to the Group. The Group's exposure to credit risk mainly arises from granting credit to customers in the ordinary course of its operations.

The Group's maximum exposure to credit risk on recognised financial assets is limited to the carrying amount at 31 December 2024 and 2023 as summarised in Note 31.1

As at 31 December 2024, for trade receivables, the Group usually provide customers with a credit term of 21 to 30 days (31 December 2023: 21 to 30 days). For the settlement of trade receivables from provision of construction services, the Group usually reaches an agreement on the term of each payment with the customer by taking into account of factors such as, among other things, the credit history of the customer, its liquidity position and the Group's working capital needs, which varies on a case-by-case basis that requires the judgement and experience of the management. For retention receivables, the Group negotiated with customers case by case on the settlement arrangement after the retention period.

The Group applies the simplified approach for trade receivables, finance lease receivables, retention receivables and contract assets to provide ECL prescribed by HKFRS 9, which permits the use of the lifetime expected loss provision for these receivables due from third parties. These evaluations focus on the counterparty's financial position, past history of making payments and take into account information specific to the counterparty as pertaining to the economic environment in which the counterparty operates. Monitoring procedures have been implemented to ensure that follow-up action is taken to recover overdue balances.

The Group assesses ECL under HKFRS 9 on trade receivables, finance lease receivables, retention receivables and contract assets based on provision matrix, the analysis of credit risk are based on debtors' ageing because these customers consist of a large number of customers which share common risk characteristics that are representative of the customers' abilities to pay all amounts due in accordance with the contractual terms.

The expected loss rates are estimated based on historical observed default rates over the expected life of the debtors and are adjusted for forward-looking information that is available without undue cost or effort. In applying the forward-looking information, the Group has taken into account the possible impacts associated with the overall change in the economic environment. At each reporting date, the historical default rates are updated and changes in the forward-looking estimates are analysed.

Trade receivables and contract assets are written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off. The Directors of the Group reviewed and considered no irrecoverable amounts should be taken account for the overdue trade receivables balances as at 31 December 2024 and 2023.

At 31 December 2024, the Group has concentration of credit risk as 43% and 76% (31 December 2023: 3% and 33%) of the total trade receivables were due from the Group's largest customer and five largest customers respectively. The aggregate amounts of trade receivables from these customers amounted to HK\$3,099,000 and HK\$5,486,000 (31 December 2023: HK\$284,000 and HK\$3,199,000) of the Group's total trade receivables at 31 December 2024.

The ECL rate applied for contract assets and retention receivables is ranging from 0.09% to 0.51% (2023: 0.14% to 0.19%). The ECL rate applied for finance lease receivables are considered to be insignificant.

For other financial assets, the Group has established a policy to perform an assessment of whether a financial instrument's credit risk has increased significantly since initial recognition on an individual basis for significant balance, by considering the change in the risk of default occurring over the remaining life of the financial instrument. The Group classifies its other receivables into Stage 1, Stage 2 and Stage 3, as described below:

Stage 1 When other receivables are first recognised, the Group recognises an allowance based on 12 months' ECLs.

Stage 2 When other receivables have shown a significant increase in credit risk since origination, the Group records an allowance for the lifetime FCLs.

Stage 3 When other receivables are considered credit-impaired, the Group records an allowance for the lifetime ECLs.

Due to one of the joint operator's uncertain financial status, the Group has taken up follow-up action towards one of the joint operators and please refer to note 17 for details. The management of the Group consider not to recognise any additional ECL allowance of the amount due from the joint operator (2023: HK\$NiI) based on lifetime ECL.

Except for the other receivables as set out in above, the management is of opinion that there is no significant increase in credit risk on other receivables since initial recognition as the risk of default is low after considering the factors set out in Note 2.7 and, thus the Group assessed that the ECL for other receivables under the 12 months ECL method. The ECL recognised based on 12-month ECL allowance is HK\$213,000 (31 December 2023: HK\$136,000) for the year ended 31 December 2024.

The credit risks on cash and bank balances are considered to be insignificant because the counterparties are banks with high credit ratings assigned by international credit-rating agencies.

#### 31.5 Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities that are settled by delivering cash or another financial asset. The Group is exposed to liquidity risk in respect of settlement of trade payables and its financing obligations, and also in respect of its cash flow management. The Group's objective is to maintain an appropriate level of liquid assets and committed lines of funding to meet its liquidity requirements in the short and longer term.

Management monitors the cash flow forecasts of the Group in meeting its liabilities.

#### 32. CAPITAL MANAGEMENT

The Group's capital management objectives are to ensure the Group's ability to continue as a going concern and to provide an adequate return to shareholders by pricing goods and services commensurately with the level of risk.

The Group actively and regularly reviews its capital structure and makes adjustments in light of changes in economic conditions. The Group monitors its capital structure on the basis of the gearing ratio. For this purpose, gearing ratio is calculated based on total borrowings divided by the total equity as at the yearend date and multiplied by 100%. Total borrowings of the Group were the lease liabilities. The management reviews the capital structure by considering the cost of capital and the risks associated with each class of capital. In view of this, the Group may adjust the amount of dividends paid to shareholders, issue new shares, return capital to shareholders, raise new debt financing or sell assets to reduce debt.
